## **Clarifications & Requirements**

- 1. Acknowledgement of all addendum received must be noted on the bid submittal form. Any and all addendums shall become part of the specifications and the bid package for the project
- 2. Signature required for acknowledgment of addendum
- 3. Questions must be submitted by 5:00pm Thursday, February 8<sup>th</sup>, 2018
- 4. Q Revealed Acoustical Ceiling tile, please provide the manufacturer along with a tile type (name) for pricing. The tile selected will then indicate the size of the ACT grid that is desired. (ie -15/16" or 9/16")
  - A USG SLT 2220 or equal
- 5. Q The new doors and frames, what was used in the past (some doors have a type or style to stay consistent with the existing doors).... All the frames are to be wood, vs a knock down or hollow metal frame correct?
  - A Yes
- 6. Q VCT is to match the existing, what is the existing style, and manufacturer?
  - A Mannington, Progressions, 55529 Ginger Snap
- 7. Q In the plotting room (that will be made into two rooms) item #6 says to reconfigure or ADD, how are we to price the HVAC? 50% new 50% reuse? Please advise
  - A Reconfigure existing supply will add one return.
- 8. Q In the Plotting Room keep everything as 6" (existing) or move to 8"?
  - A 6"
- 9. Q Alt #2 is the existing hardware on the existing entry wall "stay" if the Alternate is accepted? Or will new hardware be required?
  - A If Alt #2 is accepted hardware can remain on existing doors with the exception that all locking mechanisms on both existing doors must be deactivated.

10. Q - What is the width for the interior slider reception window?

A - The overall length of the reception counter top store front is 8'. The center horizontal slider light commercial 2 3/8" +/- depth from inside to outside ¼" clear glazing glass should have at least a minimal opening of 18". Center section shall be 4' with each side equally dividing the remaining footage. Store front shall be in dark bronze to match existing store front in reception/lobby area.
