Subject:	Upcoming Leaf Collection Season	

Public Works is preparing for the start of the loose leaf collection season, which is scheduled to commence in mid-November and continue until March 2016. Public Works will collect leaf piles that have been properly placed behind the curb or sidewalk of single family residences. During this time of year, Public Works will utilize six (6) vacuum leaf collector trucks as well as our normal contingent of six (6) knuckle boom trucks. We hire temporary staff as well during this period to operate the leaf trucks. Typically, the temporary staff is comprised of recent Public Works retirees.

During periods of heavy leaf accumulation and frequent residential raking, the collection schedule is negatively impacted. During this period, Public Works is challenged to meet the weekly service for leaf collection. At times, it is not uncommon that the leaf collection schedule is reduced to a bi-weekly schedule during this period. In the past, this has most often occurred during the initial accumulation in late November through December. In order to expedite the loose leaf collection during this period, Public Works may collect leaves six (6) days per week and utilize 10-hour work days.

Residents are asked not to mix limbs and other debris with leaf piles as this slows the collection process of the leaf vacuum trucks.
