The following items clarify, add to, delete from and/or otherwise change and supersede information previously issued to you in the Bid Documents for the above-referenced project. As such, said items shall be considered part of the contract and receipt of this addendum shall be acknowledged appropriately in the bid package. Please review the following items carefully and adjust your proposal accordingly.

Pre-bid Minutes/Clarifications/Follow-up:

- 1. See Attachment 1, pre-bid meeting minutes, which as part of this addendum shall be considered part of the contract. Bidders are encouraged to review this addendum carefully prior to submitting a bid.
- 2. All communication and submissions by the contractor shall go through SEPI Engineering for this project.
- 3. NCDOT's Inclement Weather policy shall be used for this project as outlined in the NCDOT Standard Specifications.
- 4. Hours of work are restricted to those listed in the Bid Documents. Prior approval from the City Engineer or his authorized agent is required for any work outside of the documented hours of work. Any overtime work will incur a fee at an hourly rate of \$100/hour/person (minimum of 4 hour) by the Contractor and deducted from Contractor payment.
- 5. Lowest responsive, responsible bidder will be selected based upon Base Bid only. City will select Alternates to be awarded based upon available funding.

# Changes/Additions to Bid List and Specifications:

- 1. Intermediate Contract Time #1 is revised to 330 calendar days.
- 2. Asphalt specifications for this project shall adhere to 2018 standards. All bidders are responsible for including 2018 asphalt standards when preparing their bid package submittals.
- 3. Item 25 in the Bid Form has been revised to reflect the 2018 asphalt standards. Asphalt type is now S9.5C.

- 4. Item 26 in the Bid Form has been revised to reflect the 2018 asphalt standards. Asphalt type is now S9.5B.
- 5. Bidders shall use the revised Bid Form attached to this addendum, which reflects changes to Items 25 and 26 noted above, when preparing the bid.
- 6. Rates included in bids should reflect the 2019 Davis Bacon Act requirements. New wage rate information for 2019 is attached to this addendum.

# Requests for Information after the Pre-bid meeting:

- 1. Question #1: How will the City pay for moving stockpiled unclassified excavation a second time to the location to be used?

  Answer #1: The project plans do not restrict access to any areas of the project site through construction phasing; the entire project site is available for the contractor's use. As such, it is the contractor's responsibility to ensure areas are available to which unclassified excavation can be moved and not stockpiled. Should the contractor chose to stockpile unclassified excavation due to his means and methods, no separate payment shall be made for moving unclassified excavation a second time.
- 2. Question #2: The specification for the Metal Handrail in Alternate Bid 2 and Alternate Bid 3 specifies galvanization. For Alternate 3, with steps, this would have to be built in sections, hot dipped, and welded onsite, which would break the galvanization. We would typically build this in place (weld in the field) so everything is parallel and true, then prime and paint with (2) coats of industrial primer and paint. Is this acceptable?

  Answer #2: This proposal for Metal Handrail construction, Items 110 and 127, is acceptable with the understanding the final color of the handrail shall be brown in accordance with Detail #3 on Sheet CD-4 or as otherwise directed by the City.

## **MEETING ITEMS**

- 1. Lynn Raynor, Project Manager from the City welcomed attendees and asked those in attendance to introduce themselves.
  - a. Attendance Sheet
    - Attendees are as follows: Lynn Raynor (City of Greenville), Brandon Rountree (City of Greenville), Ryan Purtle (City of Greenville), Barry Kass (Barnhill), David Stevick (Trader), Charles Parrott (Trader), Stuart O'Neil (Fred Smith Company), BJ Lanier (Lanier Construction), Garrius Jones (Lanier Construction)
  - b. Attendees were reminded that the Pre-bid conference is not mandatory.
- 2. Lynn Raynor reviewed legal requirements and pertinent bid detail for those in attendance.
  - a. Bonds/Insurance Certificates Bid Bond, Payment/Performance Bonds/Insurance Certificate, Railroad Insurance (CSXT)
  - b. Formal bid opening June 27, 2019 @ 10:00 AM
  - c. Notice to Bidders All Bidders must be pre-qualified by NCDOT and listed on the Directory of Transp. Firms at the time bid proposal is submitted.
  - d. Iran Divestment Act (p.35)
  - e. DBE Requirements/submittal with Bids (Goal 10%, p. 19)
- 3. Lynn Raynor reviewed technical specifications associated with the project and submittals.
  - a. Project is federally funded through NCDOT. As such, all NCDOT specifications, processes, paperwork, submittals, materials certifications, testing requirements, certified payrolls, Davis-Bacon, etc. apply.
  - b. Davis-Bacon Act Rates shall meet 2019 standards.
  - c. Contract Time and Liquidated Damages (p. 14)
    - Base Bid Phase 3A Only Phase 3A is being completed at this time. Intermediate Contract Time #1 is 240 calendar days. See plan cover sheet for Phase designations. (Intermediate Contract Time #1 has been revised since the pre-bid meeting. See Addendum #1 cover letter.)
    - Alternates as noted, p. 15. Additional days as noted depending upon Alternates selected by the City.
    - Work hours 8:00 AM to 5:00 PM, Monday through Friday (p.46).
    - Work outside of the specified work hours requires written approval from the City Engineer or his authorized agent (pg.46)
    - Inclement weather policies and procedures will conform to those outlined in NCDOT's Standard Specifications.
  - d. Liquidated Damages
    - ICT #1 \$750/day after the contract completion date.
    - Overall Contract Time \$500/day after contract completion date

- e. Bid Evaluation and Contract Award Lowest responsive responsible bidder (p. 48). Recommendation of contract award is anticipated at the August 8, 2019 City Council meeting. Concurrence of Award will be requested from NCDOT afterward.
- f. Description Construction of 10' wide multi-use path, including grading, drainage, paving, structure, traffic control, erosion control, waterline relocation, and related items.
- g. Phase 3A work begins on Plan Sheet C-9.
- h. Attendees were made aware that 2018 asphalt specifications shall be used in place of the 2012 specifications referenced in the plan documents. It is the responsibility of all bidders to ensure their submittal includes the 2018 specifications for asphalt.
- i. Contractor is responsible for Public Advisory notices (p. 98)
- j. Emphasis on Surveying and Layout (p. 45). Construction Surveying is included in the contract, and shall be performed in according with NCDOT specifications and all associated documents.
- k. No Major Contract Items. Specialty Items p. 16.
- 1. Access off 3<sup>rd</sup> Street double lock, Contractor purchase his/her own.
- m. Traffic Control reasonable access to residences must be maintained.
- 4. Lynn Raynor reviewed key aspects of the projects plans, pointing out the project phasing for clarification. Specifically, access is basically limited to each end of the project due to topography. Project may be accessed from 3<sup>rd</sup> Street on the east end or Colonial Avenue near Ford Street on the west end. Bidders need to consider access when preparing bids.
- 5. Final Comments
  - a. The City will have a contract with CSX and will pay for flagging separate of the construction contract. The selected contractor will have to sign the contract with CSX as well to indicate understanding of processes required to work within CSX right-of-way.
  - b. Contract Administration and Inspection for this contract will be performed by SEPI Engineering. Once the contract has been awarded, all communications will be funneled through SEPI. All submittals will go through SEPI Engineering's Project Manager.
  - c. An addendum will be sent out with pre-bid minutes and responses to any requests for information received.
  - d. Bid date Thursday, June 27, 2019 at 10:00 AM, 1500 Beatty St. Be sure to include all required documents with bids.

HIGHWAY CONSTRUCTION PROJECTS (excluding tunnels, building structures in rest area projects & railroad construction; bascule, suspension & spandrel arch bridges designed for commercial navigation, bridges involving marine construction; and other major bridges).

Note: Under Executive Order (EO) 13658, an hourly minimum wage of \$10.60 for calendar year 2019 that applies to all contracts subject to the Davis-Bacon Act for which the contract is awarded (and any solicitation was issued) on or after January 1, 2015. Unlisted classifications needed for work not included within the scope of the classifications listed may be added after award only as provided in the labor standards contract clauses (29 CFR 5.5(a)(1)(ii)).

The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage determination. The classifications are listed in alphabetical order of "identifiers" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

### Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than "SU" or "UAVG" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

## Survey Rate Identifiers

Classifications listed under the "SU" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier. Survey wage rates are not updated and remain in effect until a new survey is conducted.

# Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

### WAGE DETERMINATION APPEALS PROCESS

- 1.) Has there been an initial decision in the matter? This can be:
  - \* an existing published wage determination
  - \* a survey underlying a wage determination
  - \* a Wage and Hour Division letter setting forth a position on a wage determination matter
  - \* a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour Regional Office for the area in which the survey was conducted because those Regional Offices have responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:

2.) If the answer to the question in 1.) is yes, then an interested party (those affected by the action) can request review and reconsideration from the Wage and Hour Administrator (See 29 CFR Part 1.8 and 29 CFR Part 7). Write to:

The request should be accompanied by a full statement of the interested party's position and by any information (wage payment data, project description, area practice material, etc.) that the requestor considers relevant to the issue.

3.) If the decision of the Administrator is not favorable, an interested party may appeal directly to the Administrative Review Board (formerly the Wage Appeals Board). Write to:

4.) All decisions by the Administrative Review Board are final.
