Background

- Billy Casper (BC) Began Managing the Course on January 1, 2018.
- FY2018-19 was First Full Fiscal Year
- BC Operates with 3 Full Time and 4 Part Time Personnel (5-6 additional Part Time During Golf Season)
- COG Provided \$100K in Financial Support of the Course in Year One per the Contract
- COG to Provide \$75K in Financial Support in Year Two per the Contract

Golf Courses Nearby

- 24 courses within a 50 mile radius
- At least four other courses experienced closure or management change
