Subject: Neighborhood Improvement Grant

The Neighborhood Improvement Grant Program provides up to \$750 towards projects that benefit applicable neighborhoods. Because the City of Greenville strives to maintain quality neighborhoods, eligible projects either promote neighborhood cohesion through block/neighborhood lasting enhancement and/or maintain neighborhood attractiveness through blight removal/reduction.

Planning and Development Services staff evaluate the applications to ensure compliance with the approved program guidelines, followed by presentation to the Community Appearance Commission for final approval.

There were two applications received for this grant cycle: Greenfield Terrace and Lakewood Pines

Applications will be shared with the Community Appearance Commission prior to their meeting. Staff will be present to answer any questions before a final decision is made.

(O) Block/Neighborhood Lasting Enhancement Project

We were fortunate to receive a Neighborhood Improvement Grant this past spring and were able to make some good progress toward repair and landscaping the entrances to the neighborhood. Our priority was for the repair of the brick and mortar columns and the lights on the top of the columns, which we accomplished. However, we were able to do only a minimum amount of the landscaping. We plan to use this grant to complete that part of the project.

17. Describe how residents will be involved in carrying out the project

We have an active committee which is responsible for planting and maintaining the landscaping. Martha Engelke is the chair of the committee, made up of 6 additional volunteers. At our October meeting this year, we allocated \$200.00 for maintenance and for seasonal updates.

18. Describe the project you are proposing in detail

We plan to add a dwarf crepe myrtle to one entrance and to remove several drift roses from the current plantings, which are showing signs of the rosette disease. Instead, we will add 12 Encore azaleas providing both spring and fall blooming seasons. In addition, we will add solar-powered holiday lights to both entrances.

19. List below the basic steps you will undertake to do this project.

1. Beautification Committee will make purchases and present receipts to the treasurer;

- 2. Committee will install holiday lights and solar collectors;
- 3. Committee will remove diseased roses and plant the azaleas and one tree at the appropriate planting time;
- 4. Committee will mulch the 4 planting areas by the 2 entrances;

5. At the end of the holiday season, the committee will remove the lights and solar collectors and store for the following year.

20. How will the neighborhood/residents benefit from the project?

Lakewood Pines is on the regular Holly Jolly Trolley Tour at Christmas time. It is a source of pride for us that we can entertain and share the holiday spirit with our fellow citizens. Neighbors work hard to install large lighted Christmas globes high up in our many trees for everyone to enjoy. It is really magical. Lakewood Pines is a magical place to live and our diverse neighborhood deserves entrances that represent that.




