## 6. PUBLIC HEARING ON A REQUEST FOR A VARIANCE FROM THE HEIGHT LIMITATIONS OF THE AIRPORT OVERLAY TO ERECT TWO TEMPORARY CONSTRUCTION CRANES

The applicant, Brasfield & Gorrie, Inc., has requested a variance from the height standards of the Airport Overlay zone, Section 9-3-5 of the Greenville City Code. The request is for a variance to erect two temporary construction cranes of a 44 foot and 64 foot above the maximum height standard of 177 feet above mean sea level. The property is located at 520 Moye Boulevard (the proposed new Central Utility Plant which will serve the new Pitt County Memorial Hospital Heart Center). The property is further identified as being Tax Parcel Numbers 29138 and 29139.
