## CALL TO ORDER

Chair Johnson called the meeting to order at 5:30 p.m.

## ROLL CALL

Vice Chair Tyson called the roll and confirmed a quorum was present.

## APPROVAL OF THE AGENDA

Motion was made by Mr. Caspar and seconded by Ms. Tyson to approve the amended agenda. Motion carried unanimously.

## APPROVAL OF MINUTES OF OCTOBER 2, 2013

Amendments: Mr. Wright stated his name should be added under members present. Mr. Weitnauer stated the meeting adjourned at 6:31 rather than $7: 45$. It was noted there were errors in reference to Mr. Johnson's name and Ms. Tyson's name.

Motion was made by Ms. Powers and seconded by Ms. Tyson to approve the October 2, 2013 minutes as corrected. Motion carried unanimously.

## ANNOUNCEMENTS

Mr. Weitnauer stated Mr. Mark Abboud has resigned from the Community Appearance Commission and asked CAC members to consider encouraging other people in the community to apply for the vacant position. Ms. Diggs asked if there are any applicants in the talent bank and Mr. Weitnauer responded he will check. Mr. Caspar stated in the past, thank you letters were sent to outgoing members to acknowledge their service. Mr. Weitnauer responded it would be appropriate to mail a thank you note to Mr. Abboud and he would prepare such a letter.

## CITY STAFF INTRODUCTIONS AND COMMENTS

Mr. Weitnauer stated Mr. Mike Dail, Planner II, completed his interim service to the CAC as staff liaison. Mr. Weitnauer stated he will be serving along with Ms. Blount as staff liaison over the next few months at which time Ms. Blount will then become the permanent liaison to the Commission. With Ms. Blount's recent promotion to Zoning Compliance Officer and with demands of learning new tasks, Ms. Blount doesn't have time during these next few months to become the sole liaison.

Mr. Johnson asked if there are any new nominations. The Commission discussed whether organizations could be nominated and since it was not clear, a subcommittee was formed to review the award procedures. The subcommittee is comprised of Ms. Kulik, Mr. Caspar and Ms. Powers.

## Overview of Neighborhood Advisory Board Activities

Ms. Brenda Diggs, Neighborhood Advisory Board (NAB) Chair, provided a thorough presentation of NAB activities. The presentation was made at the request of the CAC.

## Review and Take Action on Neighborhood Improvement Grant Applications

Mr. Seth Laughlin, Planner II and NAB Staff Liaison, provided a PowerPoint presentation of three grant applications received which were all deemed to be complete and eligible applications.

Carolina East Neighborhood Association is seeking a grant of $\$ 750$ to fund landscape maintenance of two existing neighborhood signs. The Commission discussed whether a landscape maintenance project was eligible for a Neighborhood Improvement Grant application.

Motion was made by Ms. Tyson and seconded by Ms. Kulik to table the item in order to: Verify that the application is eligible for the grant; Determine who owns the land the signs are located on; and Determine the extent of the area intended for maintenance. Motion passed.

Forrest Hills Neighborhood Association is seeking a grant to fund $\$ 750$ for the fabrication and installation of seven signs to be placed on top of existing street signs within the neighborhood. The approved signs will have yellow letters on an oval purple background. The Neighborhood Association requested the color combination due to the neighborhood's proximity to ECU.

Motion was made by Ms. Powers and seconded by Mr. Wright to award a $\$ 750$ grant to the Forrest Hills Neighborhood Association to fund their proposed project. Motion passed.

Ripples of Hope Neighborhood Association is seeking a grant of $\$ 750$ to fund materials to improve neighborhood involvement in events through the purchase of a tent, banners and notebooks.

Motion was made by Ms. Tyson and seconded by Ms. Fox to award a $\$ 750$ grant to the Ripples of Hope Neighborhood Association to fund their proposed project. Motion passed.

## Adopt-A-Street

Sigma Tau Gamma Fraternity would like to adopt Stancill Dr. from Meade St. to the Tar River. Motion was made by Ms. Powers and seconded by Ms. Tyson to approve the adoption. Motion passed.

## Select the Next Meeting Date

Since the next meeting date would normally fall on January 1, a proposed date of January 15 was discussed. The Commission approved the rescheduled meeting date.

## Review and Approve the 2014 Meeting Calendar
