  - 1. Recreation Update
    - a. Ms. Kriewall shared a PPT of various programs.
    - b. The City has updated their website and we will no longer use the web address <u>www.grpd.info</u>. The only web address for the City will be <u>www.greenvillenc.gov</u>.
    - c. Fall Festival to support the United Way on 10/18 at Five Points Plaza from 10am 5pm.
    - d. Also on 10/18, Annual Adaptive Sports Day at Bladez on Ice with sled hockey from 12 2pm.
    - e. Specialized Recreation Costume Party is scheduled for 10/29 from 6-8pm at the Drew Steele Center.
    - f. NRPA Congress is next week in Charlotte, numerous staff members are going including Gary Fenton, Mark Gillespie, and Shana Kriewall.
- B. Mark Gillespie, Parks Superintendent
  - 1. Golf/Parks Update
    - a. The Bradford Creek Golf Course Advisory Committee has two (2) vacancies. Commissioners Darin White, Deb Garfi and Audrey Nealy volunteered for a committee to review applicants and recommend specific appointments to the full Commission.
    - b. Shared video of Mike Cato teaching the First Tee Program at Third Street Community Center.
    - c. Shared a picture of new signage at Green Springs Park regarding fossils.
  - 2. Capital Project Update
    - a. Tennis Courts Resurfacing completed at Thomas Foreman Park; Elm Street Park courts are almost complete.
    - b. Elm Street Center Restroom Renovation Demolition is complete, modernizing, ADA accessible, and should be complete in November.
  - Tar River Legacy Plan Mr. Gillespie shared a video of the consultant's presentation from the TRLP's third public meeting. The final plan will presented to City Council in November.

### VIII. NEW BUSINESS

A. Town Common Rankings and Recommendations

The Recreation and Parks Commissioners were asked to rate the possible projects for the Town Common. The Commissioners' combined rankings were : 1 – walkway from parking lot to the amphitheater, 2 – ornamental benches, 3 – floating fishing pier, 4 – vinyl coated picnic tables, 5 – dumpster relocation with pad and PVC fencing, 6 – recycling bin/trash can combo, 7 – water fountains with pet fountain, and 8 – decorative park entrances. A motion was made to direct staff to adjust quantities of ranked items so all eight (8) projects could be completed within the \$150,000 budget and recommend approval to City Council.
