**Site Visit on June 30, 2016**

1. A site visit was conducted immediately after the Pre-bid meeting was completed.
2. Access to the pool area for a visual inspection, measurements and discussion of work to be completed was held.

**Clarifications & Requirements**

1. Acknowledgement of all addenda received must be noted on the bid submittal form. Any and all addenda shall become part of the specifications and the bid package for the project.
2. Use the attached revised bid submittal sheet when turning in the bids. Provide a bid price for each line item.
3. Water blasting can be used in lieu of sand blasting for the removal of the existing surface of the pool.
4. Include in the scope of work for the protection and cleaning of the walls, ceiling, etc. that may be needed once the work is complete.
5. Remove from the scope of work the repainting of the lane markers and end wall targets. Provide and install black tile that shall match the existing size and length of the existing lane markers and end wall targets.
6. Delete painting of any depth markers on the pool deck. The existing are tile and will need to be protected the work on the pool and the deck.

7. Under Alternate #1: change the manufacturer's warranty for the Sherwin Williams product from two (2) years to one (1) year.
8. Remove all painted plastic pipe/drain covers that are currently in the pool prior to refinishing.
9. Include in the base bid to replace all drain covers and fittings. It shall be the responsibility of the Contractor to have any required inspections by the Health Department completed as needed. Contractor shall provide a copy of the completed inspections at the end of the project.
10. **NEW – Alternate #2** – Provide a price to include the scope of work in the base bid with a finish of 100% quartz in lieu of the specified Marcite.
11. **NEW – Alternate #3** – Provide a price to repair the existing pool surface and repaint the pool and lane markers with an acceptable product within the industry in lieu of installing the new plaster finish.

**Bids are due Tuesday, July 12, 2016 at the Jaycee Park Administration Building, 2000 Cedar Lane, Greenville, NC. Bids will be accepted up to 2:00 P.M. There will not be a public bid opening. Bids will be opened by staff and a bid tabulation sheet will be available upon request once the contract is awarded to the successful bidder. *Note: Mailed proposals will be accepted up to the 2:00 P.M. deadline. All proposals received in the mail will be stamped with the date and time or receipt.***
