<u>Site Visit – September 30, 2016</u>

- 1. A site visit was conducted immediately after the Pre-bid meeting was completed.
- 2. Access to view the area of work for a visual inspection, layout and discussion of work to be completed was held.

Clarifications & Requirements

- 1. Acknowledgement of all addenda received must be noted on the bid submittal form. Any and all addenda shall become part of the specifications and the bid package for the project.
- 2. <u>The reception desk area is illustrated as having a cutout in the glass with a speak easy but the scope of work (Item 22 on page 9) calls for a sliding glass window with lock. Please clarify Answer; Cutout in the glass with speak easy</u>

- Please indicate where the two "new" aluminum "interior" doors are to be as per the scope of work (Item 19 on page 9).
 Answer; "Exterior" store front entry doors in new store front wall
- 4. <u>Also, please note that the existing storefront is very faded dark bronze aluminum and new storefront</u> will NOT match existing!

Answer; We understand that there will be a difference.

- 5. <u>Monitors to be provided and installed by owner?</u> Answer; Yes
- <u>Demo only after hours, but new work can be during normal business hours?</u>
 Answer; Any loud and obstructive work such as saw cutting, removal of walls, framing, electrical/HVAC interference with staff must be done after normal business hours.
- 7. <u>Ceiling material for new vestibule? add insulation in ceiling?</u> Answer; Use current material. No insulation.
- 8. <u>Carpet patch or replace at Engineering Hall where door is removed and relocated?</u> Answer; VCT tile will be install in the new Engineering Hall to match current VCT tile on other side of the door being removed and relocated.
- 9. <u>Should we include an allowance for any above ceiling issues that may not be per code?</u> Answer; No
