#### Bylaws Review

## NEW BUSINESS

#### Neighborhood Improvement Grants

Mr. Whisnant, representative from Cherry Oaks North Board of Directors, presented a final report. The project included replacing the landscaping of two entrance islands. The total cost of the project was \$1,581 of which the Neighborhood Improvement Grant provided \$750. The balance was funded from the HOA fund. Mr. Whisnant recommended that the City's subdivision ordinance mandate homeowner associations for new subdivisions in order to maintain the common areas or landscaping maintenance.

#### Community Appearance Award Nominations

Chairman Johnson explained the procedures for submitting nominations. He requested votes and the nominees with the most number of votes for September were selected: The Boundary at West End, 630 Cotanche Street and Alice Keene Park, 4561 County Home Road. Mr. Alligood volunteered to take the sign, the certificate and letter to The Boundary and to pick it up before the next Commission meeting.
