

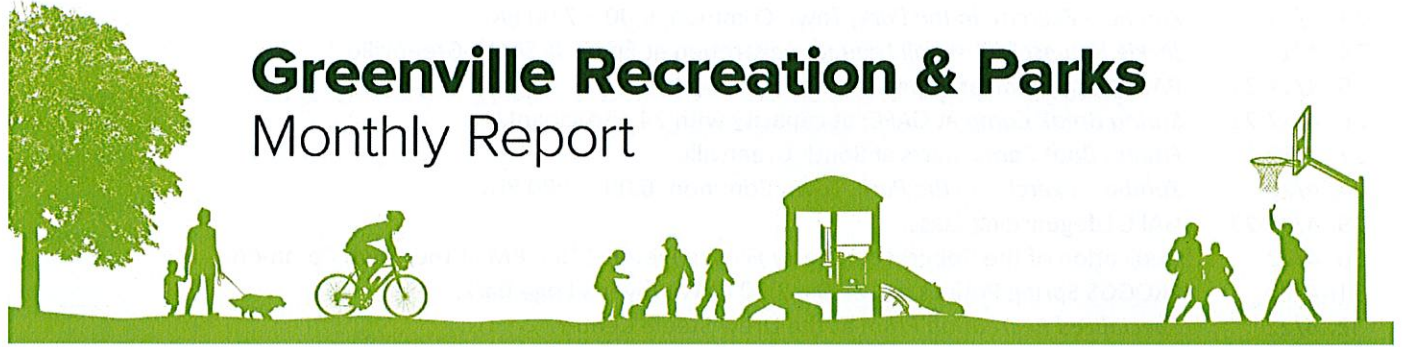

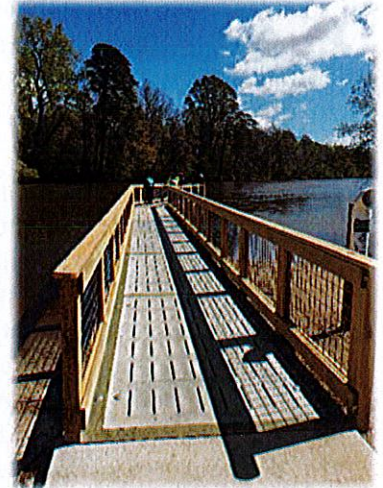

PARKS DIVISION

PARKS COORDINATOR

1. Cheyenne Craft started as a new Designated PT Park Ranger on 3/7. Cheyenne is the first female Park Ranger employed by the City of Greenville.
2. The new playground equipment is currently being installed at Westhaven Park. The old backstop was removed and a new shorter backstop was installed at the left rear corner of the park away from the playground. There is a sign posted indicating that the use of the new backstop is intended for wiffle ball and kickball. A park information sign will also be installed, as will a “danger” sign to warn people of the possible drowning hazard in the retention pond behind the park fence.
3. The work on the HVAC replacement at H. Boyd Lee Park began on 3/20. Work is ahead of schedule and should be completed by mid- April. No change orders have been received and none are expected.
4. A pre-bid meeting was held on 3/28 for the replacement of the shelter roofs at **Peppermint Park and Jaycee** Park. The existing shingle roofs will be replaced with new, forest green, metal roofs. Bids received 4/6.
5. Installation of the new roof covering at the Facility Management building began on 3/13 and was completed on 3/27. The project was completed on time and within budget. 



PARKS MAINTENANCE

1. Landscape crews – Annual ballfield restoration underway; sports turf management active (irrigation, aerating, top dressing, mowing and herbicide spraying); delivered mulch to FROGGS garden; removed debris from Greenway Cleanup day.
2. Technician crews – Repairs from water leakage/damage completed at Administrative Office; provided support for Greenway Cleanup; repairs completed to all sport field lights; winterized water services being restored. Smaller projects: Replaced air filters on all HVAC systems; removed vandalized play panel at Kristin Drive playground; removed graffiti at South Greenville shelter and Kristin Drive playground; installed metal roof on storage shed at Soccer Complex.
3. Hurricane Matthew recovery projects are still active and repairs continue. Temporary construction fence installed on Greenway around erosion damage; renovations completed to restrooms at Matthew Lewis Park.

PARKS PLANNING

1. South Greenville Recreation Center
 - a. The Contractor will meet with Parks Maintenance staff to review concerns regarding multi-purpose fields and will make repairs based on staff feedback and punchlist items.
 - b. The Contractor will complete the installation of interior signage by mid-April.
 - c. The cores for the GRPD patented locking system have arrived and will be installed by the vendor by mid-April.
2. Town Common
 - a. Contractor is making adjustments repairs to the Cool Mistlers playground component, with a local plumber installing a pressure reduction valve so the components function properly. Work will be completed by mid-April.
 - b. The new fishing pier is complete and includes railings to meet ADA standards. GRPD received a proposal to complete a no-rise certification and engineering design for the kayak launch. Staff is currently waiting on approval to move forward and accept the proposal.
 - c. GRPD received two Statements of Qualifications (SOQ) in response to the RFQ that was advertised for construction documents for the gateway plaza and restroom building. An evaluation panel will review the SOQs and recommend for the preferred design team for the project.
 - d. Bids for demolition of the radio tower have been received, and the City is currently in contract negotiation with the low bidder. Demolition is scheduled to begin on 4/18.
 - e. GRPD has received a Community Development Block Grant to install a picnic shelter at Town Common. Equipment will be acquired by mid-April; construction will be completed in late spring.
3. Tar River Legacy Plan
 - a. A plumbing contractor will provide a hose bib for water at the overlook at River's Edge Park in mid-April.
 - b. Sound Rivers, Inc. has begun construction on the second of three camping platforms, this one on the GUC Water Treatment Facility property. It will be substantially complete in early May.
 - c. The Phase I Environmental Study for 7 acres at the old landfill on 2nd Street has been completed. The site has been proposed for recreation improvements, and early indications do not suggest hazardous materials in this area. The City is getting borings in five locations to confirm this.
4. Park Land Acquisition
 - a. The first public input meeting for a new park in Westpointe Village was held on 3/22. The final closing and contract to purchase the parkland will occur in mid-April.

Chairperson Diane Kulik introduced herself and thanked everyone for coming out to the meeting. Chairperson Diane Kulik then called a short business meeting to order and asked each police officer, city staff, and committee members to introduce themselves.

Chairperson Diane Kulik asked the citizens to hold all of their questions and comments until the guest speaker had completed his presentation.

GUEST SPEAKER: Sgt. Donald Manley

Recognizing Gang Activity in Our Community - Sgt. Donald Manley, Gang Unit - Special Operation Division

Sgt. Donald Manley, from the Gang Unit, spoke on the topic – Gangs, Youth and Violent Crimes (Problems in our Community). Sgt. Manley began his presentation by giving the definition of a gang and gang activity. He stated:

Gang: *A group or association of three or more persons who may have a common identifying sign, symbol, or name and who individually or collectively engage in, or have engaged in, criminal activity or creates an atmosphere of fear and intimidation. Criminal activity includes juvenile acts that if committed by an adult would be a crime.*

Activities: includes fighting, vandalism, graffiti, armed robbery, weapon offenses, assaults and drug dealing. He stated that not all gang members are engaged in illegal activities.

Sgt. Manley stated that there are: 4 classifications of Gangs

- ❖ **Street gangs-** a group of adolescents &/or young adults who see themselves as a group & have been involved in enough crime to be of considerable concern to law enforcement & the community.
Traditional: (Crips, Gangster Disciples, Bloods - UBN, Latin Kings, V.L.)
- ❖ **Drug gangs-** small cohesive group with a main focus on money & drug sales.
Note: Drug gangs can be subgroups of street gangs.
- ❖ **Neighborhood gangs-** more informal group without widespread ties.
- ❖ **Hate Gangs-** Motivated by racial or ethnic biases. (Aryan Brotherhood, KKK,

White Supremacists, Black Separatists)

Sgt. Donald Manley mentioned these: Early Indications of Gang Membership

- ❖ Poor school progress and achievement.
- ❖ Truancy
- ❖ Sudden change in personality / behavior.
- ❖ Problems at home.
- ❖ Draws gang signs / graffiti, Use of hand signs.
- ❖ Tattoos or branding on the body.
- ❖ Dresses in gang type attire. (shows interest in one or two particular colors)

Sgt. Manley stated “**Why do people join gangs?**”

- Fun and excitement
- Identity
- Peer pressure
- Financial gain
- Fellowship / Sense of Belonging
- Protection

Gangs: 3 main classifications

- **Street:** a group of adolescents &/or young adults who see themselves as a group & have been involved in enough crime to be of considerable concern to law enforcement & the community.
Traditional: (Crips, Gangster Disciples, Bloods - UBN, Latin Kings)
- **Prison:** A criminal organizations that originated within the penal system and they have continued to operate within correctional facilities throughout the United States.
- **Outlaw Motorcycle:** Organizations whose members use their motorcycle clubs as conduits for criminal enterprises.

Sgt. Manley discussed **Ways to join a Gang**

- **“Jumped In”:** Allowing the members to beat on you for a pre-determined number of minutes.
- **“Blessed In”:** Being able to join the gang without having to be “jumped in” or “sexed in.” Usually occurs when the prospect has a family member already in the gang.
- **“Sexed In”:** Females – By having intercourse with multiple members of the gang.

BANDANAS

Gang members will represent their set by “flagging,” or wearing bandanas. These bandanas or “flags” can be worn around the head, face, wrist, ankles, or in their back pocket. Having a flag is very significant to a gang member; typically flags are given at the time of initiation into the gang.

It is considered disrespectful to let a flag fall on the ground and rival gang members will make a show of throwing their rival’s flag on the ground and stepping on it to show disrespect.

Law enforcement can also show disrespect by taking or throwing the flag on the ground. However, it is encouraged to NOT disrespect their flag and to return it during an encounter. By doing this you will be able to gain a little of their respect for future encounters or confrontations.

Sgt. Manley stated that **Gang: It's a mindset. It's what *THEY* believe.** Here are examples of prayer, pledge, oath and motto.

Blood Prayer: "When I die, bury me 5 feet deep not 6 feet, with 2 pitch folk across my chest with a tattoo of a heart on my chest with a red flag around my head with 2 double barrel guns going down my legs with three burns on my right arm or leg standing for the the UBN."

Blood Pledge: "I pledge allegiance to our flag United Blood Nation in our chapter and to the real OG for what we stand. I Blood under one blood set must carry out a burner at all times and 4 every blood. Peace Almighty."

Blood Motto: "Blood in, Blood out. You heard." Blood Concept of War: "Bloods are supposed to be 110% gangsta. A Blood is to eat anyone who goes against Blood so harshly that they would not want to retaliate. A Blood is not to have beef with, eat, rape or rob any neutral at all."

Blood Oath: "Blood ain't no part time thing. It's being down when you're by yourself, getting caught and not telling, killing and not caring, dying and not crying, love for yourself, not your enemies."

Sgt. Manley went over the two types of gangs:

I. Street Gangs / BLOODS and UBN

- *People Nation Alliance*
- Color used is RED.
- Orient to the RIGHT.
- Associate with the number 3,5 & 9. (Crown and Star).
- "Slob" is derogatory.
- Under each group is a set or sub set. (GKB, 9-tre, SMM, and V-Day.)

II. Street Gangs / CRIPS

- Color used is BLUE.
- Orient to the LEFT.
- Associate with the numbers 3, 6 & 8. (pitchfork and star)
- "Crab" is derogatory.
- Under each group is a set or sub set.
- (8-tre, 74- Gangster Disciples)

III. Street Gangs / Sureno 13

Sureno = South

Colors Include: Blue and White

Lastly Sgt. Manley went over the difference between Tagger and Gang Graffiti. He stated:

Tagger Graffiti: is viewed by the tagger as Urban Art. The graffiti is ornate and colorful, with artistic letters and designs.

Gang Graffiti: is the newspaper or bulletin board for gangs, they communicate messages or threats, including challenges, warnings & pronouncements of crimes.

- Most importantly it glorifies the gang and makes their existence well known.
- Both of these are illegal.

Sgt. Manley surprised the citizens at the end of his presentation with an actual gang member present. He was hidden behind a curtain to protect his/her identity. The citizens were allow to ask questions to the gang member.

Public Expression and Questions

The citizens asked several questions, and made comments and concerns regarding the living the life of a gang member.

Chairperson Diane Kulik asked for a motion to adjourn the meeting.

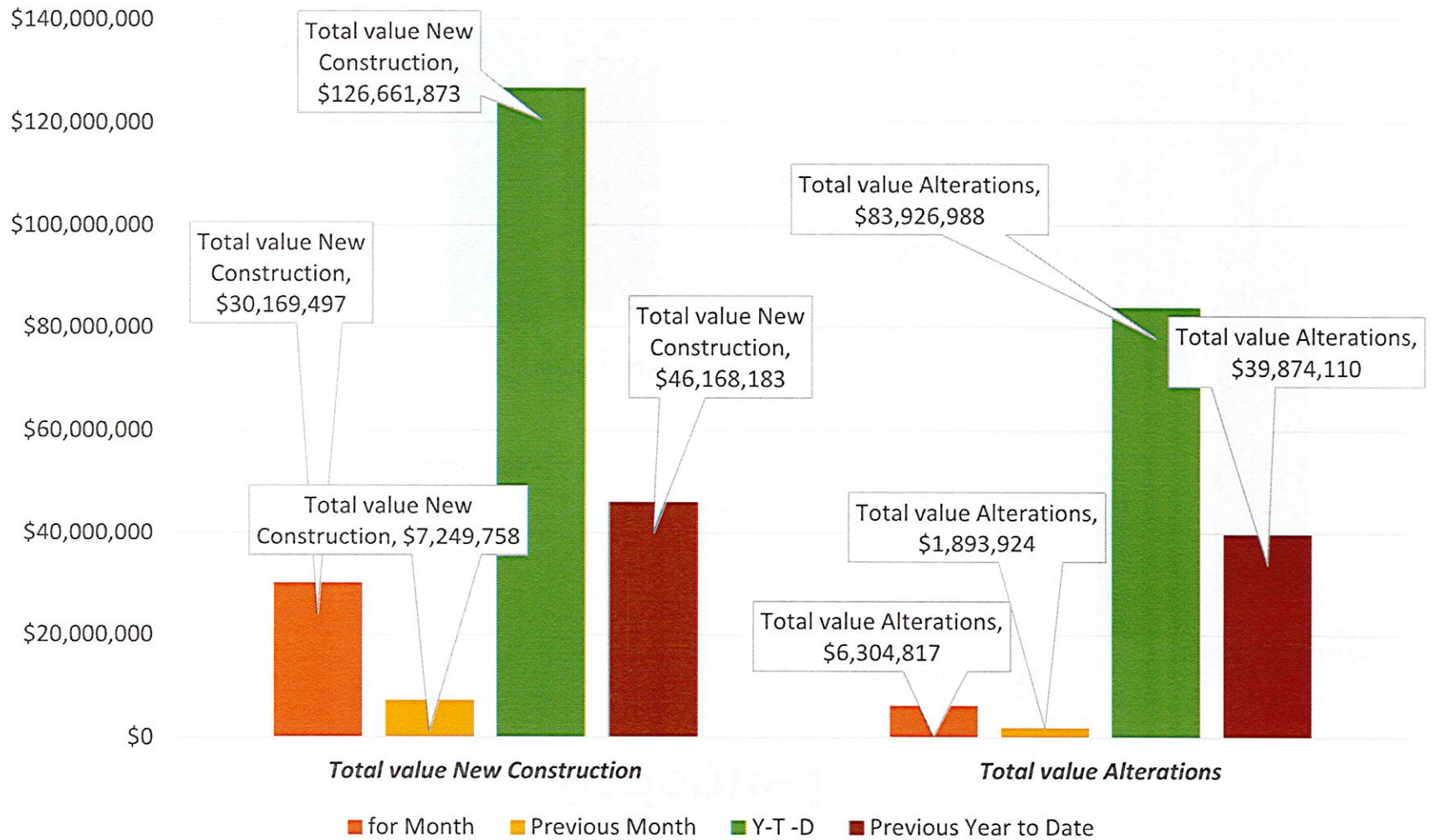

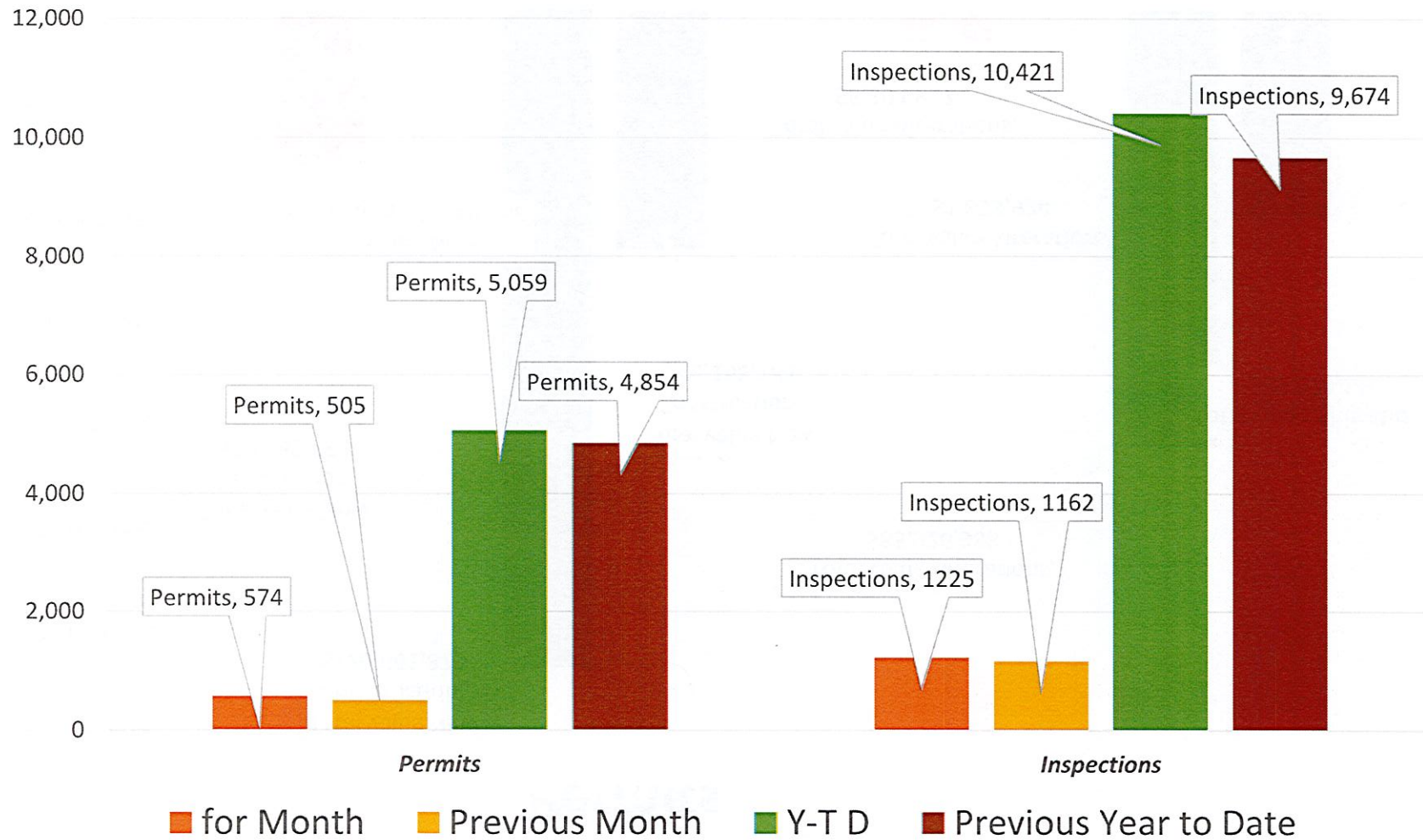

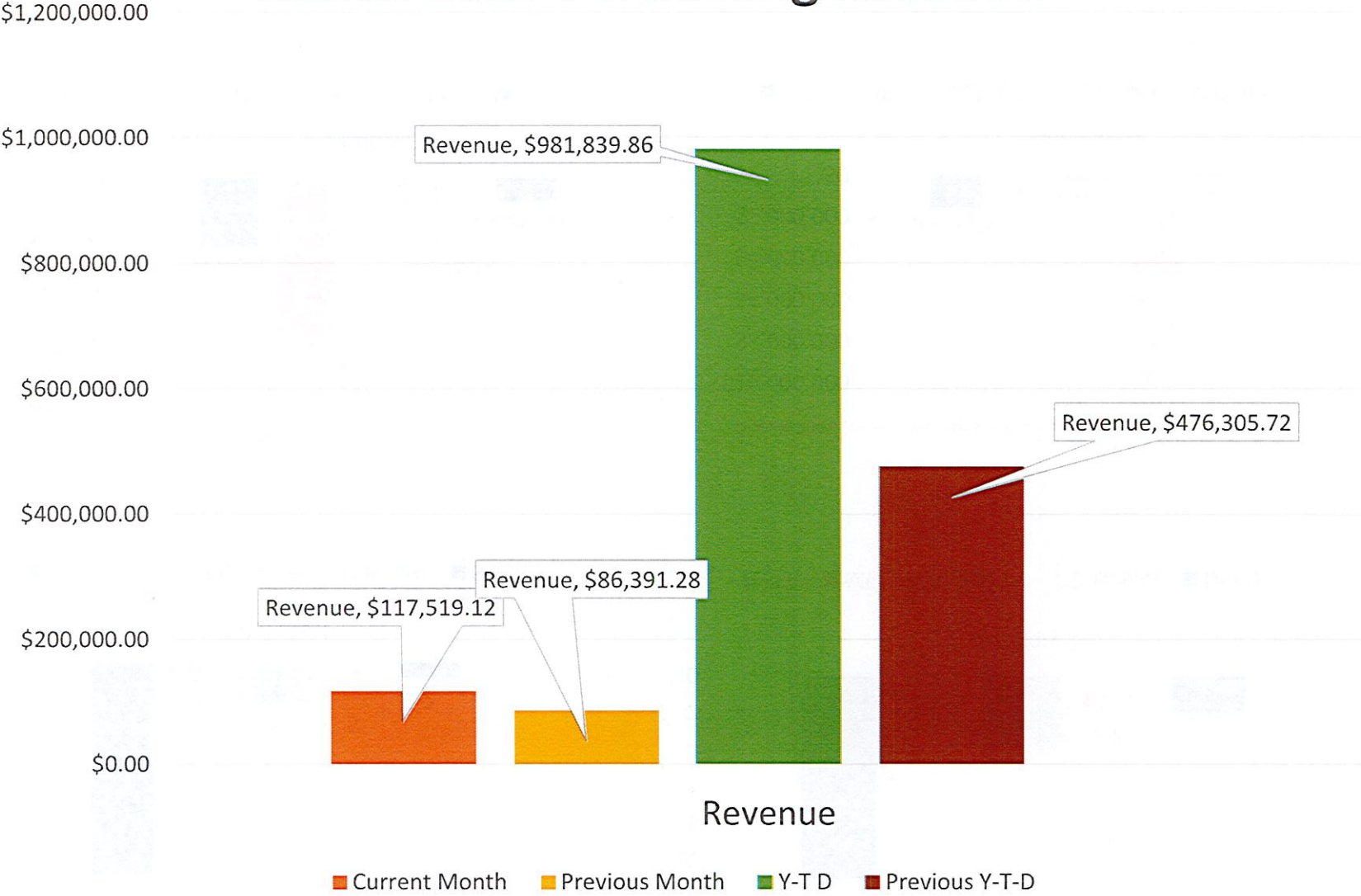
March 2017 Value of ALL Construction Permits



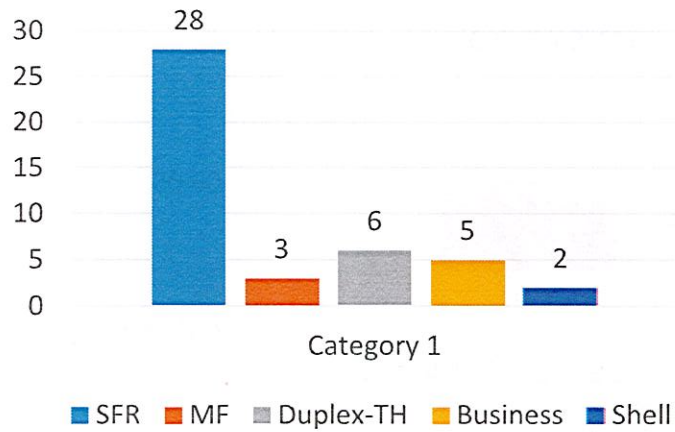
March 2017 Permits Issued & Inspections Performed



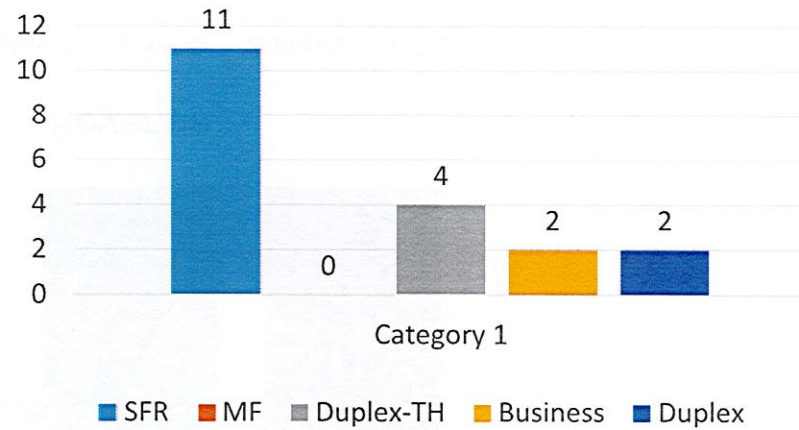
March 2017 Permitting Revenue



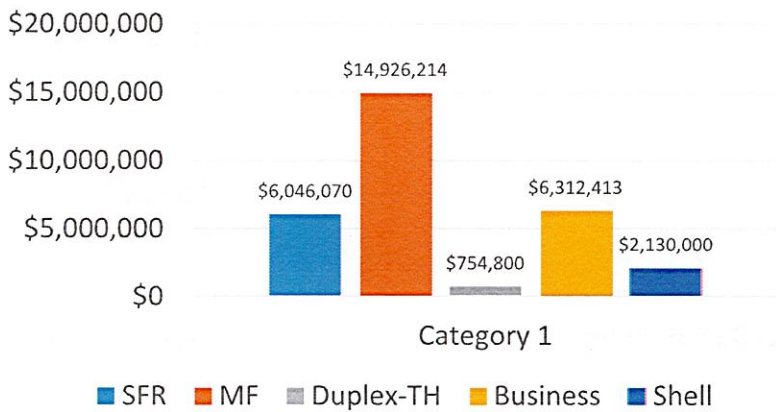
March 2017 New Construction Permits



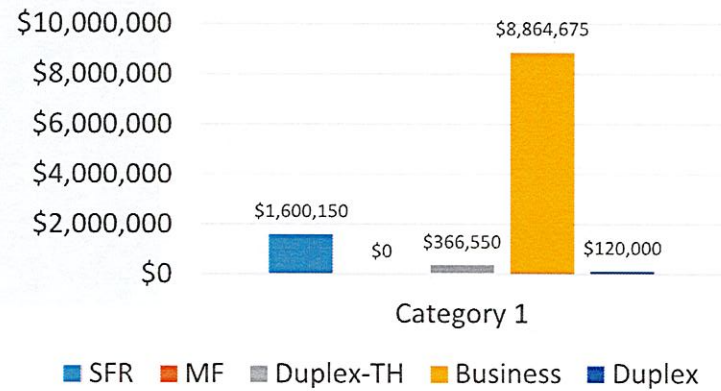
March 2016 New Construction Permits

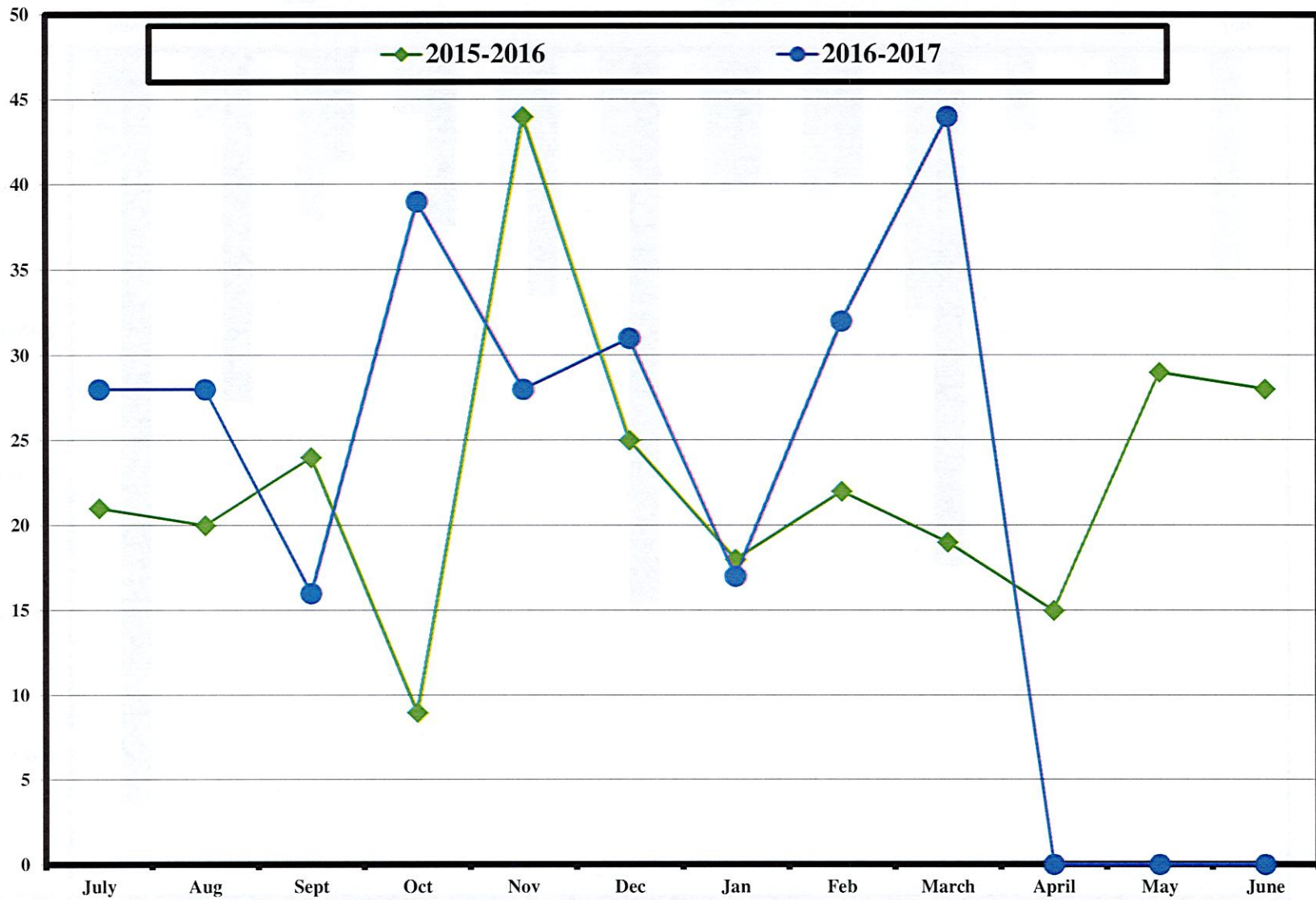


March 2017 New Construction Permit Valuation



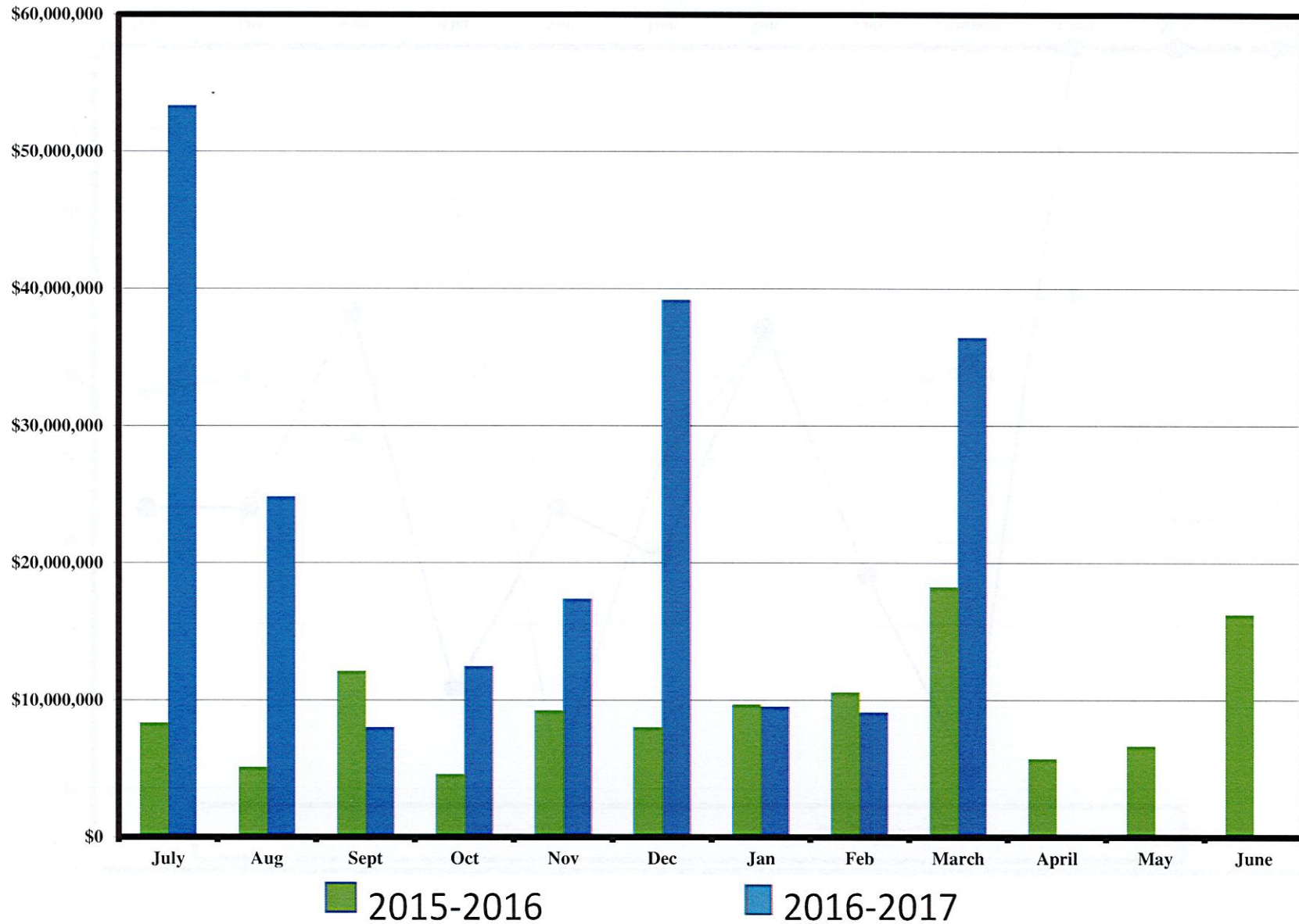
