SUBJECT:

City of Greenville Downtown Public Wi-Fi

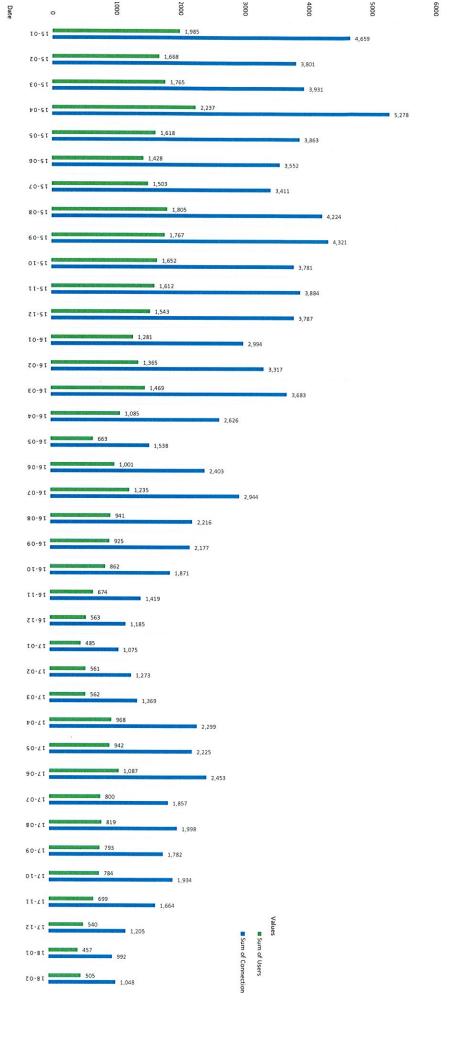
In mid-2007, the City of Greenville installed a wireless Internet service in the downtown area. This service provided free Wi-Fi to patrons that visited the downtown area from Reade Circle north to 1st Street and from Reade Street to Pitt Street. The Wi-Fi signal was not strong enough to penetrate most buildings in the area, so service was only available in common areas. The system was active until a lightning strike took place in late March 2018 which damaged components of the wireless network, rendering the service inoperable in most of the downtown area.

As smartphones and tablet computers have become more prevalent, usage of the Wi-Fi service has greatly declined. Most businesses in the service area have free Wi-Fi available to their patrons. In the first three months the service was provided there were over 20,000 connections. This past February there were just over 1,000 connections. Since the service has been down, IT has not received any telephone calls or emails inquiring why the system is not available.

The City does provide public Wi-Fi service in the Town Commons and all City buildings in the downtown area. Current plans are not to purchase a new wireless Internet network to replace the Wi-Fi service that was installed in 2007. The cost would be more than the benefit, especially since the City would be competing with downtown businesses and wireless carriers that provide Wi-Fi services.

IT is requesting the service be discontinued and no funds expended to replace the service. The outdated wireless equipment will be removed as convenient opportunities present themselves.

Subject: Traffic Safety - Delineator Deployment Initiative

The Public Works Department has an on-going goal of evaluating and improving safety on roadways within the City. The Department works in conjunction with accident report data provided from the Police Department.

A Safety Committee has recently been established with the overall goal to reduce the number of motor vehicle and pedestrian accidents in the City of Greenville. The Committee was established with the Police Chief as the chair and with the following stakeholders:

- Greenville PD
- Greenville PWD
- Greenville Urban MPO
- NCDOT
- ECU
- Vidant Health

Goal Establishment and Criteria:

- Consideration of accident trends to provide accident reduction measures at high accident locations (HAL's)
- Consideration of locations with higher incidents of Police documented citations and/or observations for traffic infractions
- Methods to reduce pedestrian and bicycle conflicts with motor vehicles
- Investigation to improve pedestrian crossings both at intersections and mid-block

Public Works and the Police Department have been coordinating efforts to reduce accidents on City of Greenville roadways. The Police Department responds to motor vehicle accidents within the City and maintains a database of these events. Public Works uses this data to analyze accident statistics at specific locations as well as types of accidents in an effort to provide engineering solutions to resolve the cause of such accidents.

After an investigation into the latest defined HAL's, the two departments are jointly recommending mitigation measures to reduce the number of accidents at these HAL locations.

Based on the preliminary field investigations, six locations were selected for further evaluation to identify a conceptual design to estimate cost for the delineator systems, with the goal to restrict the left or through movements (from side roads or driveways) that were the primary contributing factor to the accident clusters at each location. The locations are:

- Arlington Boulevard / Wimbledon Drive
- Charles Boulevard / Turnbury Drive

- Charles Boulevard / Smythewyck Drive
- Charles Boulevard / Oakmont Drive
- Charles Boulevard / Elm Street
- Greenville Boulevard / Belvedere Drive

These locations and the layout for the delineator installation are shown within the attachment. It is estimated that the equipment necessary to implement these designs will cost approximately \$10,000 per location, or approximately \$60,000.00 total for all six. Public Works staff will install the necessary equipment.

Recommendation

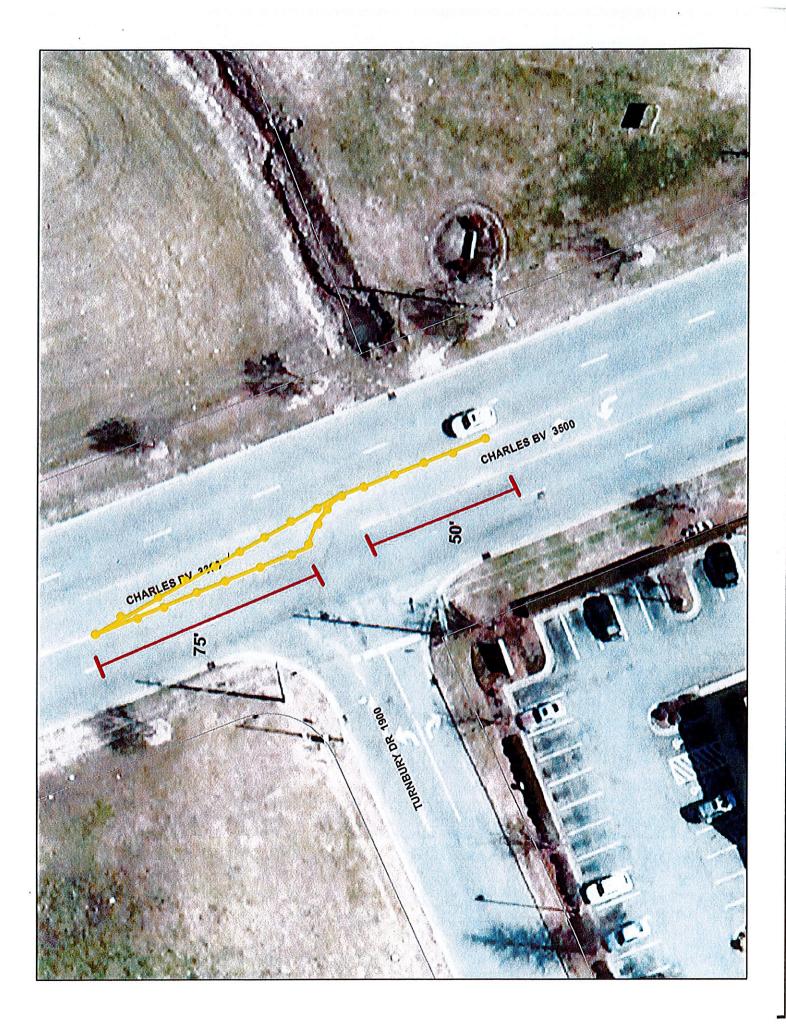
The Police and Public Works Departments recommend the installation of these center delineator/curbing systems that will prohibit movements that are causing accidents at the HAL locations. These restrictions will change the side street/driveway access to right-in/right-out access only. The attachments show the intent of the designed limits of the restrictive action and the product installed at the pilot location (Arlington / Walmart-Smythewyck.).

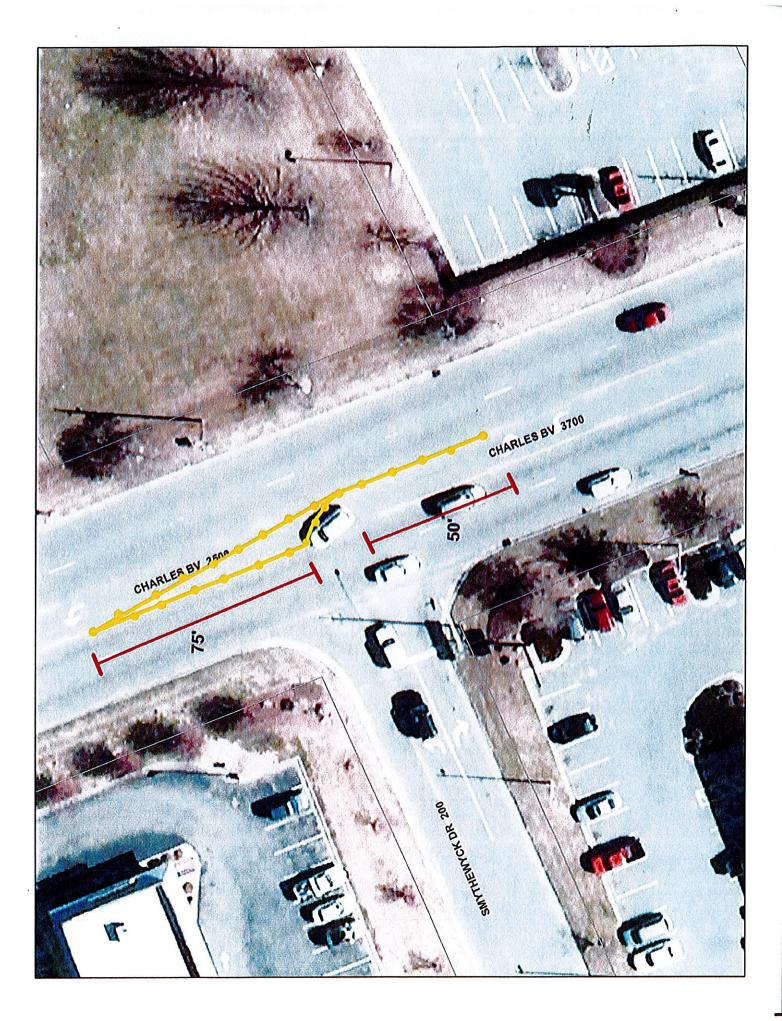
The proposed mitigation is the next step in providing improved pedestrian and vehicle safety at the listed locations. These locations experience high numbers of accidents related to left-turning vehicles and/or two-way center left turn lanes. Public Works and the Police Department will continue coordination in analyzing statistical data in an effort to mitigate these accident types.

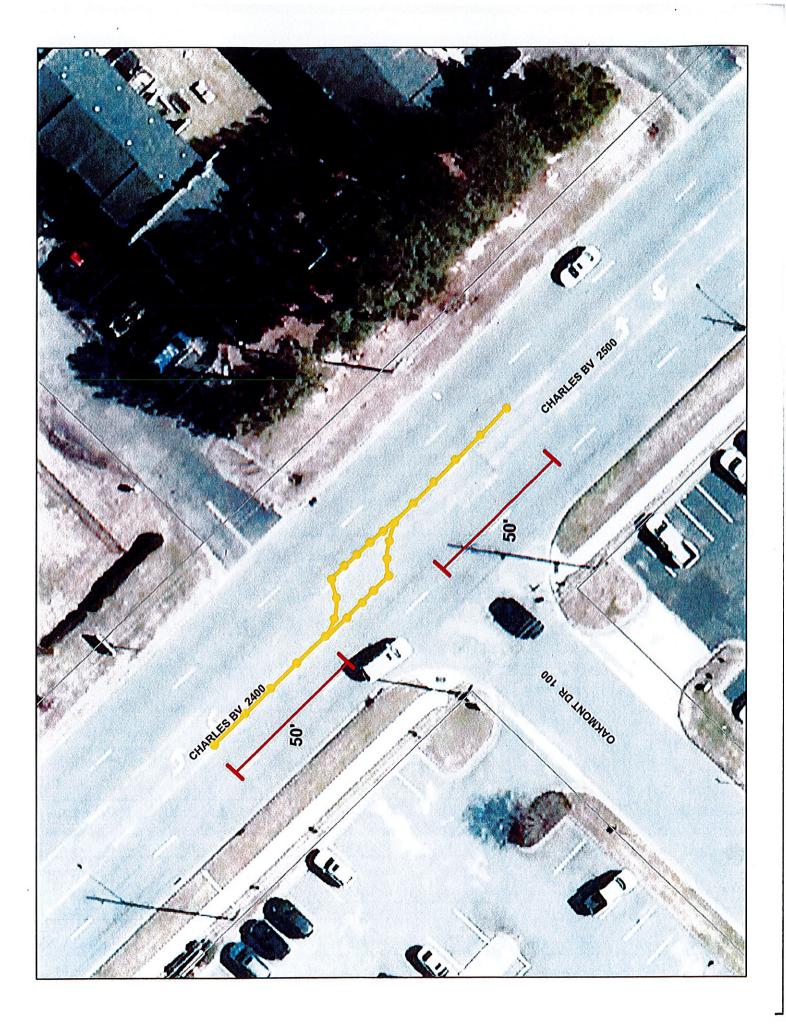

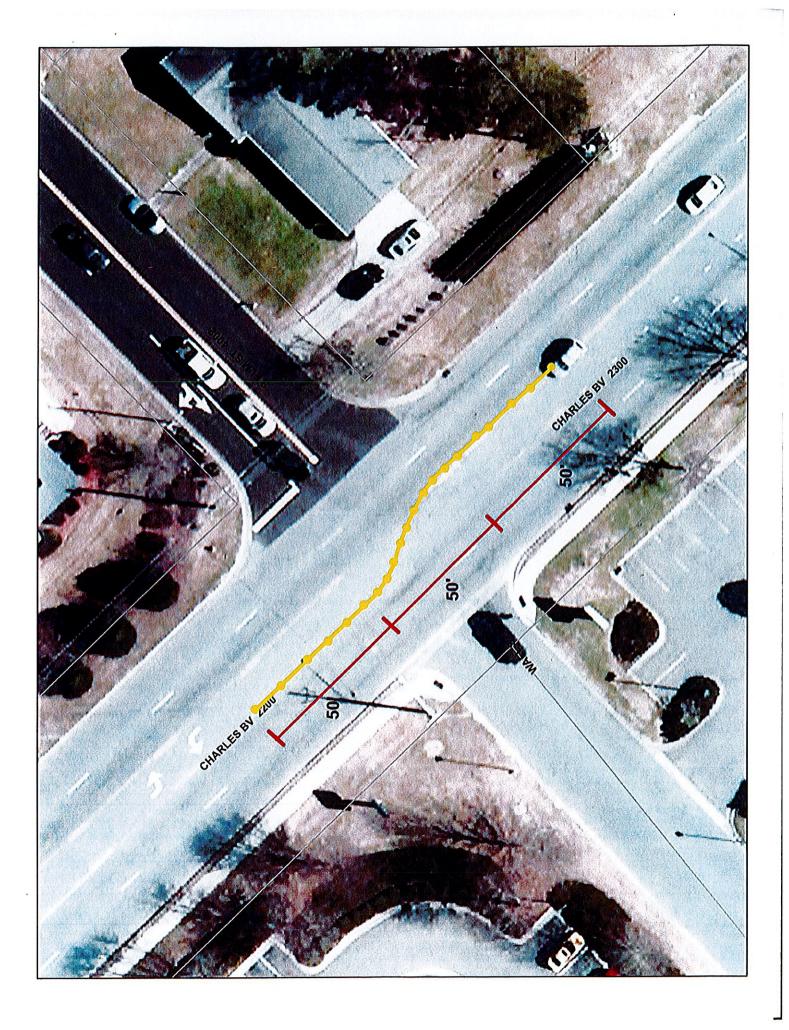

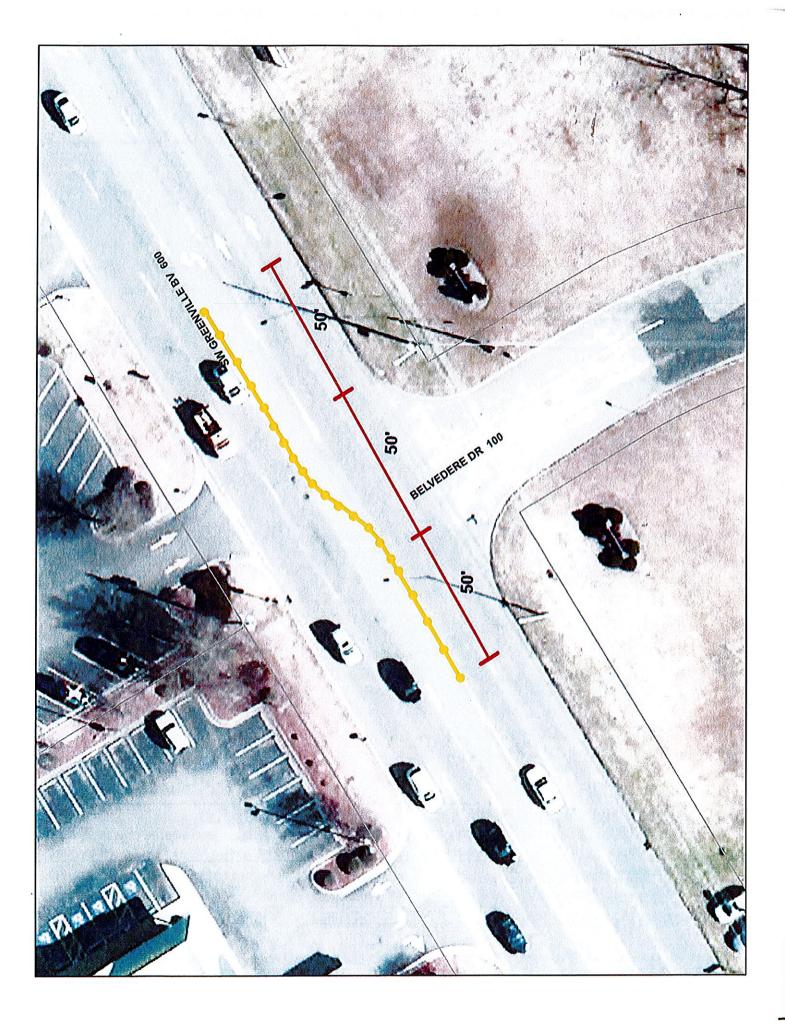

SUMMARY MINUTES FOR THE POLICE COMMUNITY RELATIONS COMMITTEE

Chairperson Diane Kulik called the Police Community Relations Committee meeting to order at 6:30 p.m., at The Church of Jesus Christ of Latter-Day Saints, Greenville, NC.

INTRODUCTION OF COMMITTEE MEMBERS

Chairperson Diane Kulik asked each committee member and city staff to introduce themselves.

APPROVAL OF THE AGENDA

Chairperson Diane Kulik asked for a motion for approval of the agenda. A motion was made and seconded. The agenda was unanimously approved by the committee.

APPROVAL OF THE MINUTES

Chairperson Diane Kulik asked for a motion for approval of the April 10th, 2018 Minutes. A motion was made and seconded. The minutes were unanimously approved by the committee.

MISSION AND PURPOSE OF MEETING

Chairperson Diane Kulik read the Police Community Relations Committee mission statement.

Diane briefly discussed the Police Department's three designated zone substations. Then she introduced Sgt. Glen Webb.

Sgt. Glen Webb showed a power point presentation while discussing that aspects of Internet Safety. He discussed his experience and knowledge of internet risks that he gained while working with the Special Victims Unit.

He discussed some risks that come with not supervising children while on the Internet; one risk being cyberstalking. He explained that cyberstalking is any threats, repeated harassment or

pranks that communicated through the internet. He stated that children put entirely too much personal information on the internet, without thinking about risks and consequences. There are a lot of fraudulent crimes that occur on the internet from gaining personal information.

There has been a growth in cybercrimes in dealing with child exploitation. He discussed how perpetrators are constantly on the internet posing as kids to gain access to children for criminal means.

He shared information about the many apps that kids are using and how to research for safe apps. He talked about how to discuss internet safety with children; and how to put in place safeguards as parents to protect children. He discussed how communication with your children is one key to keeping your children safe.

He stated that you could find more resources for internet safety at local law enforcement agencies; from school resource officers; at the National Center for Missing/Exploited children; and from the FBI/SBI ICAC Task Force.

Detective Grady discussed how internet gaming is also a popular activity for kids. His experience also comes from working with the Special Victims Unit. He discussed how it can become an addiction. He stated that kids spend so much time on gaming because they connect with other people while playing the games. He stated that one idea for safety is to research names on the internet that your kids may connect with. He even suggested research your own children's' names because some try to have a social network with false names, to hide it from their parents. They don't fully understand the risks that they are taking.

Lt. Carlton Williams stated that Family Sharing is the best app that you can have on the IPhone. He stated that he uses it with his family. He also suggested monitoring your children while they are on the internet, especially if they use headphones.

There was discussion on how cyber bulling is becoming the worst type of bullying for children today.

Everyone thanked Sgt. Webb and Detective Grady for coming and sharing this information.

Motion was made to adjourn. Motion approved.
