Subject:	Façade Improvement Grant Review		

Internal Audit has completed the review of the selected sample for the Façade Improvement Grant (FIG) program. The objective of the review was to determine whether the processes and controls are adequate and proper documentation is maintained.

Seventeen grants were reviewed from fiscal years 2013-2017. Testing verified processes from the initiation of the grant to reimbursement after completion. Reimbursements for the sample totaled \$53,205.76 over the five fiscal years. The review identified discrepancies in the following areas:

- Lack of documentation to verify program requirements;
- Written extensions were not received and extension timeframes were unclear;
- Incomplete application documentation submitted/maintained;
- Incomplete documentation submitted/maintained for reimbursement request;
- Insufficient documentation to support verification of work performed at closeout;
- Reimbursements at more than 50% of the actual project cost;
- Project construction started prior to contract agreement.

A meeting was held with the staff coordinator to discuss the findings. Internal Audit recommends the following in order to strengthen the program:

- Develop an Administrative Procedure for the FIG program that documents the processes and procedures from initiation to reimbursement after completion;
- Review program guidelines every two years to ensure the guidelines are most efficient;
- Utilize EnerGov to maintain all documentation related to the program;
- Internal Audit should review all documentation prior to reimbursement each year.

Internal Audit and staff will work to resolve the above findings and implement tools to increase program efficiency.

It should be noted that within the five year period reviewed, there were at least three coordinators managing this program. The program continues to improve as progression was shown in the latest years reviewed. Internal Audit is confident that staff will implement the necessary changes to ensure the program operates efficiently and consistently in the future.
