First accredited in November 1995, the Department is required to undergo a CALEA reaccreditation on-site assessment every four years. ACCREDITATION ASSESSMENT TEAM INVITES PUBLIC COMMENT

A team of national assessors from the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA) will arrive on Sunday, August 04, 2019 to examine all aspects of the Greenville Police Department's policy and procedures, management, operations, and support services.

The assessors will verify that Greenville Police Department meets the Commission's professional standards. This is part of a voluntary process to gain accreditation, which is considered a high recognition of law enforcement professional excellence. The Greenville Police Department first received its accredited status in November of 1995 and has been successful in maintaining the high expectations and identified professional standards since that time. The Department must be assessed every four years and is now up for its eighth reaccreditation assessment.

As part of the on-site assessment, agency employees and members of the community are invited to offer comments at a public information session on Monday, August 5, 2019 at 6:00 PM. The session will be conducted in the City Council Chambers at the Greenville City Hall, located at 200 West Fifth Street.

If for some reason an individual cannot speak at the Public Information Session but would still like to provide comments to the assessment team, he/she may do so by telephone. The public may call (252) 329-4595 on Tuesday, August 6, 2019 between the hours of 3:00 PM and 5:00 PM.

Telephone comments as well as appearances at the public information session are limited to 10 minutes and must address the agency's ability to comply with CALEA's standards. A copy of the standards is available at the Greenville Police Department. The local contact is Megan Styron, Accreditation Coordinator, 252-329-4362.

Persons wishing to offer written comments about the Greenville Police Department's ability to meet the standards for accreditation are requested to write: Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA), 13575 Heathcote Blvd., Ste. 320 Gainesville, VA 20155

The Accreditation Program Manager for Greenville Police Department is Megan Styron. The assessment team is composed of law enforcement professionals and trained civilians from out-of-state agencies that are usually similar in size to the agency they are assessing. The assessors will review written materials, interview individuals, and visit offices and other locations where compliance can be witnessed. The assessors are: Chief Williams Welch of the Lewiston Police Department in Lewiston, Maine and Retired Lieutenant Harold LeMay of the Avon Police Department in Avon, Connecticut. Once the Commission's assessors complete their review of the agency, a full written report will be sent to the Commission. Members of the Commission will then decide if the agency is to be granted re-accredited status.

Accreditation is for four years, during which the agency must submit annual reports attesting continued compliance with those standards under which it was initially accredited.

Uptown Greenville wrote and was awarded a \$10,000 grant from the Pitt County Health Department to develop a conceptual design and define the associated construction costs of adding a bike and pedestrian path along the Town Creek Culvert project between $1^{st} - 5^{th}$ Streets.

The Uptown Greenville Board of Directors is pleased to present the City a check for \$10,000. This joint effort between the City, County Health Department, and Uptown Greenville promotes walkability and, if actualized, would provide connectivity between the University, adjoining neighborhood and the Central Business District. Additionally, the proposed bike/pedestrian path has potential to create an iconic arts pathway for our community and is a key component of the 2019 BUILD Grant application.

WK Dickson working in coordination with the Town Creek Culvert project and the contracted firm Kimley-Horn produced two alternatives designs, included. To balance cost and aesthetics of the project, staff is likely to recommend of a combination of the two designs.
