SUBJECT: GFR Celebrates Fire Prevention Month

Fire Prevention Week is celebrated nationally during the second week of October each year and is the longest running public health observance according to the National Archives and Records Administration's Library Information Center. At Greenville Fire/Rescue, we dedicate the entire month of October to promoting safety throughout the community. As many as 90 programs are scheduled to take place through the City of Greenville in daycares, public and private schools, libraries, senior housing residences, and other community events.

Home fires burn faster and hotter than in years past and most families only have two to three minutes to escape their home from the time the smoke alarm sounds. That's why families should take heed of this year's Fire Prevention Week Campaign, "Not Every Hero Wears a Cape. Plan and Practice Your Escape!"

Prevention is the best protection a family has to escape a fire. While fire deaths in North Carolina have decreased from last year at this time, we should not stop providing community awareness around this risk as even one fire death is one too many.

#### APPROVAL OF THE MINUTES

Greg Rubel read the mission statement. Scott Snyder introduced the speaker, Major David Bowen and explained that he would be discussing the Shot Spotter system.

Major Bowen discussed the Shot Spotter system. He discussed how it is a new tool being implemented to increase response time to shots fired calls. He stated that while it is still in a learning phase for the Police Department, there's proof already that it will be a beneficial tool for deterring shots fired.

Officer Jonathan Young introduced himself as the Drone Coordinator for the Police Department. He discussed the new drones and how they will be used to assist in certain situations. After answering a few brief questions, Officer Young gave a demonstration on one of the drones outside of the Police Department.

Major Bowen then provided a tour to everyone in attendance to the Communications Division, where all tele-communicators perform their duties. Lead Tele-communicator Brad Cayton gave a brief description of the duties of tele-communicators.

After the tour the committee members were given revised PCRC By-Laws by Donald Phillips. There was a vote on changing the meeting time from 6:30 p.m. to 6:00 p.m. The response was unanimous by the committee.

A motion was made to adjourn the meeting by Carol Ann; seconded by Gregory Barrett.
