1. What is the estimated cost of the Agenda Management System project?

The current NovusAgenda agenda management system interfaces with the OpenText Document Management system. Some of the supporting documents reside in the OpenText Document Management system. NovusAgenda integrates with Outlook for email notifications.

8. Can the Department elaborate on any additional drivers behind this acquisition that may not be addressed in the RFI?

City of Greenville response to question 8:

No. The City has issued an RFI to better understand the various products that may be considered for an acquisition.

13. How long has the City been using OpenText as their document management system?

City of Greenville response to question 13:

The City implemented document management called SoftSolutions by WordPerfect in 1994, which was then purchased by Novell in 1995. Due to Y2K non-compliance, the City migrated to PC DOCS Group International Inc DOCS Open Enterprise Suite in 1999. Hummingbird Ltd acquired PC DOCS in the fall of 1999 and DOCS Open became DOCSFusion and DM. In 2006, Open Text Corporation purchased Hummingbird and rebranded the product as eDOCS DM. The City has been on this document management platform for approximately 20 years and upgraded to version 10 in the summer of 2015.
