Subject:	Co-Responder Model with Integrated Family Services				

As announced in August, the Greenville Police Department (GPD) began working with Integrated Family Services' (IFS) Mobile Crisis Team to address immediate needs of individuals who encounter law enforcement and are experiencing a behavioral health crisis. Now we are pleased to share GPD and IFS have collaborated to incorporate a true Co-Responder "On-Duty" model. This initiative is a direct response to the national call for enhanced public safety responses and protocols, which include non-traditional community-based partners to deliver the highest and safest level of care to those in crisis.

Below are a few of the listed roles for each party:

- IFS will place two mobile crisis workers at GPD for two shifts for 40 hours per week working "on-duty" during peak hours in the afternoon and evenings seven (7) days a week.
- IFS will hire, train, and provide supervision to the mobile crisis workers as well as provide an agency vehicle and cellular phone for the mobile crisis workers.
- Mobile crisis management services provided are reimbursable by Medicaid and some other private insurance companies.
- The mobile crisis workers placed at GPD will respond to any mental health related call that GPD deems as appropriate.
- The IFS mobile crisis management team will provide a next-day follow-up with the individual served and will assist with development of a crisis plan to address current symptoms and to prevent a future crisis.
- The IFS mobile crisis management team will provide quarterly in-service educational sessions to GPD Communications Center staff, detectives, and patrol officers.
- GPD will provide office space for the mobile crisis workers.
- GPD will meet monthly with IFS to review aggregate data, workload analysis, and trends.
- Outside of the agreed upon hours the mobile crisis worker is at GPD, GPD can continue to request mobile crisis management services through the mobile crisis management hotline.

There will be no cost to the City through the end of the current fiscal year. In May 2021, GPD and IFS will discuss the financial aspects of the positions moving forward. IFS is in the process of

hiring individuals to fill these positions. Once the selected individuals are hired, GPD will announce the official start of the Co-Responder Model. A formal press conference will be announced in the near future to introduce the enhanced program to the public.

Should you have any questions regarding the mechanics of the co-responder mental health model, feel free to reach out to me.

It is important to note Mobile Crisis services are not exclusively available to law enforcement. Their services are available 24 hours a day, 7 days a week, to anyone, regardless of insurance, living in the following counties: Beaufort, Bertie, Brunswick, Camden, Carteret, Chowan, Columbus, Currituck, Craven, Dare, Gates, Hertford, Hyde, Jones, Martin, Nash, New Hanover, Northampton, Onslow, Pamlico, Pasquotank, Pender, Perquimans, Pitt, Tyrrell and Washington County.

Re:	Greenville Means Go Safely Initiative

I wanted to share an update with Council on the work that the marketing subcommittee of the Greenville Business Recovery Task Force is doing to help Greenville businesses recover from the effects of the COVID-19 pandemic. Research in many fields clearly shows that safety is the first concern that both residents and visitors have when making decisions on where to spend their discretionary income. The marketing subcommittee of the Greenville Business Recovery Task Force, which is made up staff members of the Chamber, Convention & Visitors Bureau, Uptown Greenville, ECU, and the ENC Alliance, recognize this. As a result, the subcommittee is working to promote safe practices to our local businesses with the goal of reassuring consumers that businesses within the City of Greenville are taking to correct protocols to keep them safe and are indeed open for business.

Our subcommittee is asking businesses in Greenville to make a commitment to "Go Safely" and show their customers that they are following correct protocol when it comes to properly sanitizing and operating safely. The protocol that they are agreeing to include the following:

- Screen staff members Ensure employee health prior to arrival each day
- Wear masks All staff when social distancing is not possible
- Hand safety Ensure hand sanitizer and washing areas are available
- Clean environment Cleaning and sanitizing thoroughly between guests

The Greenville-Pitt County Chamber of Commerce has created a landing page to promote the Greenville Means Go Safely Campaign to our local community and businesses. (<u>www.greenvillenc.org/membership-benefits/commit-to-go-safely/</u>) Businesses can take the pledge to commit to the above safety practices and will then be recognized and promoted on the website. Participating businesses will also receive a window cling with the developed logo for this campaign for quick recognition by customers.

The subcommittee will be marketing this initiative quite aggressively during the holiday season and beyond through social media, videography, and news releases.

This initiative is not specific only to Greenville, and will reach out to all of Pitt County with specific support for the municipalities of Ayden, Bethel, Falkland, Farmville, Fountain, Grimesland, Simpson, and Winterville. Members of the subcommittee are scheduled to present details of the Go Safely initiative to the Pitt County Commissioners on Monday, December 7<sup>th</sup>.
