Title of Item: Presentation of the City of Greenville Fiscal Year 2022-23 Proposed Budget

**Explanation:** As included in the Council adopted budget calendar, staff will present the City of Greenville Proposed Fiscal Year 2022-23 Operating Budget during the April 25, 2022, City Council Meeting.

In compliance with Section 160A-148(5) of the North Carolina General Statutes, the City Council will hold a public hearing on Thursday, May 12, and consider adopting the annual budget ordinance on Monday, May 23.

In summary, the Proposed City Operating Budget for Fiscal Year 2022-23 stands at approximately \$149.7 million with the General Fund comprising approximately 64% of the total. The following is a breakdown of the Proposed Budget by Operating Fund:

Staff will present an overview of the specific highlights of each fund's Proposed Budget at the April 25, 2022 Council meeting. During the May 9, 2022 City Council meeting, representatives from the Pitt-Greenville Convention and Visitors Authority, Sheppard Memorial Library, and Greenville Utilities Commission will present their proposed Fiscal Year 2022-23 budgets.
