- The City of Greenville received \$20 million in funds for transit for shelters, replacing panels at current shelters and bike racks on buses. Use of the money was in the planning phase.

Update on AECOM Presentation

- This would be a Hybrid system on demand system
- Phase 1 would replace route 4 with an on demand route
- Phase 2 would reduce the other 5 routes from 1 hr to 30 minutes expand more on demand
- ECU is starting the process on how to join forces since they cover a lot of the same areas the GREAT system covers
- Migrating to a hybrid routes will allow for more cover and better coverage for the residents of Greenville

South Tar River Greenway Phase 3 (EB-5539)

- Greenway under construction from Pitt Street to Nash Street, along the river. Our last update we were working through negotiations with CSX and the contractor on agreement revisions and changes to work in the area of the railroad underpass.
- We received the agreements back from CSX last week. We are close to reaching an
 agreement on additional cost and schedule with the contractor. Due to proximity to
 the holidays, getting on council agenda, and scheduling CSX flaggers, it will likely be
 January before the remaining work begins and should take approximately 3 months
 to complete.

BUILD Grant update

The 5th Street roadway/streetscape contract is currently advertised for bids, with bid opening in mid-December, likely award in February pending FHWA approval.

The greenway/Multi-Use Path contract will be advertised in January.

10th Street Bicycle and Pedestrian Crossing Feasibility Study

The report is wrapping up. We can expect a presentation by the next meeting.

NCAMPO Conference

Greenville will host the 2023 NCAMPO Conference. The conference will take place at the Greenville Convention Center from April 26 to 28. We ask our local members to attend and participate in the event. The theme/tagline for the conference will be Shifting Gears: Transforming Transportation. The theme was in part influence because 2023 was designated as the Year of the Trail.
