Subject: National Night Out 2023

National Night Out (NNO) is an annual event that serves to build camaraderie and connect law enforcement officers with their local neighborhoods and community. Typically held on the first Tuesday in August, this year NNO will be held on **October 3, 2023**. The first Tuesday in October is the alternate date that is provided by the national organization for locations suffering from extreme heat during the summer months, specifically August. This year we will host the annual event at the Town Common.

In years past, we have gone to several different locations where neighborhoods and organizations have hosted block parties. This has included Uptown (Five Points Plaza), Greenville Housing Authority, and numerous other communities. However, a decline in overall participation, a desire to bring the community together in a central location, and the ability for staff to visit with all communities led to the decision to host the event in one central location.

Having participated in NNO for many years, we have had the opportunity to assess what works best for our jurisdiction. The Town Common offers the opportunity to centralize the food trucks, allow for entertainment, and allot a space for all communities to participate by erecting a tent to represent their respective neighborhood. We will be able to use the amphitheater for entertainment as well as the bathroom facilities in place at the Town Common. Food trucks, kid's games, and law enforcement displays will also be present.

Neighborhoods and communities that wish to hold a block party can still participate and host their own; however, the goal is to provide more support for one location to better allocate the resources we have available.

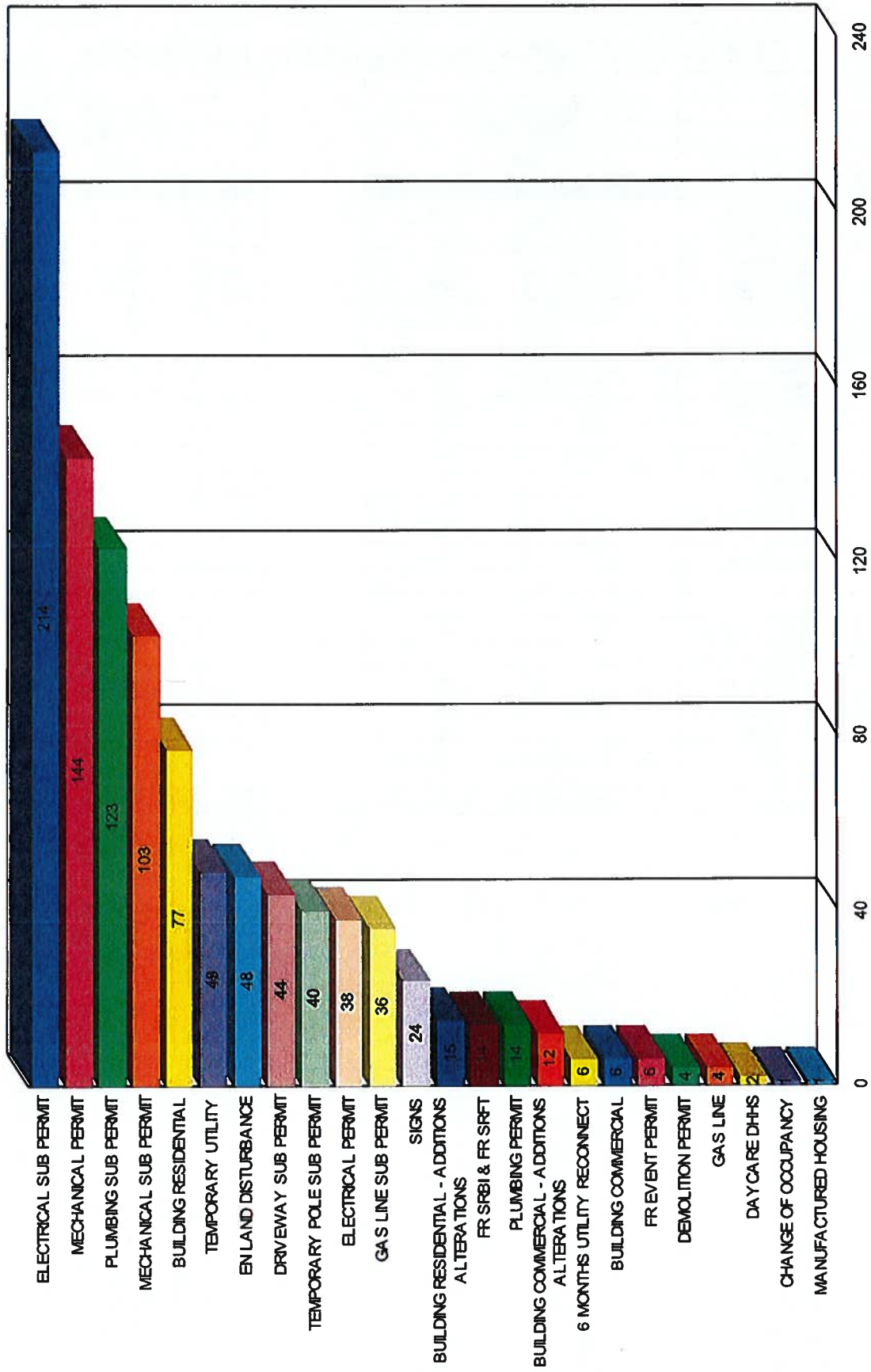
Greenville Recreation and Parks, Uptown Greenville, East Carolina University, and NC Department of Public Safety will also be partners for this year's event.
