2. General Project Information

- A. General Scope of work includes: The fabrication and installation of gateway sign as detailed in the plans. Scope includes, but is not limited to, fabrication and installation of the sign, site grading, erosion control, electrical, lighting and landscaping.
 - 1. No Underground Facilities or Hazardous Material Contamination are known to be onsite.
 - 2. The contents of the plan set and scope were reviewed.
- B. Project construction will be a lump sum bid with alternate.
 - 1. Unit Prices for work not included in the Base bid but typical to site construction are requested on the bid form.

E. Performance Period



- 1. Base Bid 180 Calendar Days with an anticipated start of Early Fall 2023.
- F. Liquidated Damages are set at \$500/Day.
- G. NCDOT Encroachment requirements.
 - Emphasized that the contents of the encroachment agreement included in the bid documents need to be thoroughly reviewed and contractor is required to meet all requirements included in the document
- H. MWBE participation goals. 10% MBE Goal and 6% WBE Goal. Contractors to take care to thoroughly read the requirements and submit the correct forms with the bid proposal. If incorrect documents are submitted in the bid proposal, the bid may be disqualified.
- I. E-Verify Compliance Include affidavit in bid proposal
- J. Bid Bond of 5% are required for this bid.

3. Questions and Answers

- A. Is this project intended to be completed by a sign company, rather than a contractor? With the amount of detail and specifics in the plans, clearly there has been substantial input by a sign company.
 - ANSWER: This project is intended to be completed by a general contractor with other trades subcontracted under the general contract. The working drawings have been completed by a design consultant; a sign company has not been consulted.
- B. Is there a General Contractor that is in Charge of the project or is the Awarded Company considered to be the contractor and handle all aspects of the project including Landscaping, Electrical & Traffic Control?
 - ANSWER: The awarded company will be considered to be the contractor and will be responsible for complete delivery of the project as indicated in the project documents.
- C. Can we bid the entire project without a GC license?

 ANSWER: No, only licensed general contractors are eligible to bid.
