Greenville Pedestrian Safety Improvement Project

Description of our project:

Greenville Pedestrian Safety Improvement Project (\$4,000,000) -This project addresses pedestrian safety through a variety of at-grade treatments along several of our transportation corridors identified in the Active Transportation Plan as part of our high-injury network. The project would focus on East 10th Street, South Memorial Drive, and Statonsburg Road. Treatments could include but are not limited to pedestrian hybrid beacons, median refuge islands, rectangular rapid flash beacons, and access management. Attached the Bicycle & Pedestrian Crash Analysis developed as part of our Greenville Urban Area Active Transportation Master Plan (ATP).
