3. APPROVAL OF DECEMBER 7, 2023 MINUTES

A motion was made by Dr. Shaw to approve the December 7, 2023 minutes. The motion was seconded by Mr. Trevathan and passed unanimously.

Dr. Shaw announced that our chairman Dr. McKinnon's new book is out. Dr. Shaw mentioned that he has a copy of the new book and it's very interesting about biodiversity in ancient lakes. Mr. Monico mentioned even if you are not a biologist or a science person this book is very interesting.

6. OLD BUSINESS

A. Kyle Brown gave a presentation on Community Solar.

Some highlights:

- What is community Solar? A program in which the local utility will install a solar facility and make the output of that facility make available to customers for purchase.
- Why community solar at GUC? Over the last several years there have continued to see a growing interest in renewable energy. Pacifically from residential customers.
- The two 5 mega watt solar facilities will be at Rams Horn Road and Fleming School Road.
- **B.** Dr. McKinnon mentioned it was time for EAC elections for chair and vice-chair.

A motion was made by Dr. Zipf to nominate Dr. McKinnon for chair and Dr. Newman for Vice-Chair for 2024. The motion was seconded by Dr. Shaw and passed unanimously.

- C. Dr. Zipf asked about what month would be good to invite Dr. Suzanne and Betsy Huddleston to an EAC meeting to discuss Air-Quality monitoring. Dr. Zipf will reach out to both Dr. Suzanne and Betsy Huddleston to check their availably.
- **D.** Dr. McKinnon reviewed the PowerPoint draft for the EAC Council Presentation for 2024. The EAC will review the final PowerPoint in February.

This presentation included the 2024 Goals:

- 1. Establish permanent Sustainability Coordinator position to:
 - 1. Coordinate city, community, and GUC operations to reduce Greenhouse gas emissions, save money on energy.
 - 2. Fulfill a goal of horizon's 2026 Plan of formulating a Green Energy Plan for the city.
- 2. Work with GUC to encourage shift away from unhealthy, climate warming fossil fuel (natural gas) and toward renewable energy; recommend to council on how to improve oversight to these ends.
- 3. Continue to encourage community environmental stewardship through Facebook posts, collaboration with the Sierra Club, outreach events.
- 4. Investigate and make recommendations regarding regionally important air pollutants.
- 5. Research funding, location opportunities for additional EV charging stations; make recommendations to Council.
- 6. Review current tree protection, planting policies and make recommendations to Council.

A motion was made by Mr. Gardner to approve the EAC Goals. The motion was seconded by Mr. Trevathan and passed unanimously.

- **E.** Mr. Gardner mentioned that Ms. Maxwell had reached out to Kevin Heifferon about scheduling a time to reserve the conference room for the Tree Working Group to meet on January 9th. There hasn't been any word back from Kevin Heifferon to confirm the time and date. Mr. Norris noted that we would need to get managements approval for staff and after hours. Mr. Norris stated he would check on this to see if he could get it approved.
- **F.** Dr. Newman reviewed the Clean Energy Resolution that was previously emailed out. Some revisions to the wording on number 2 and 3 were made.

A motion was made by Dr. McKinnon to adopt the Clean Energy Resolution with the revisions that were discussed. The motion was seconded by Mr. Trevathan and passed unanimously.
