Subject: Installation of Trash Trap in Greens Mill Run

On October 9, 2023 City Council approved a licensing agreement with Sound Rivers that allows Sound Rivers to place a trash trap in Greens Mill Run at Greensprings Park.

Trash traps are passive litter collection devices that are built to withstand the rigors of flash rain events typical in urban watersheds, allowing water to flow through the trap unimpeded, at the same time capturing larger pieces of trash floating downstream.

Trash trap installation and maintenance is part of Sound Rivers' Litter Free River program which aims to reduce macroplastic and litter pollution from the Neuse and Tar-Pamlico river basins as well as engaging with community members and volunteers regarding trash and microplastic pollution. Trash traps are designed to be installed in stream channels at least 10 feet wide, with flashy flows and no known recreational impacts (non-boating areas or fishing locations). In the event of extreme predicted weather, the traps can be removed. All trash is removed from the site and disposed of properly by Sound Rivers volunteers.



The Greens Mill Run trash trap is the fifth installed as part of this program. Over the past two years, traps have been installed on Jack's Creek in Washington, Duffyfield Canal in New Bern, Little Rock Creek in Raleigh and Adkin Branch in Kinston. The public is welcome to attend the installation on March 27, from 10 a.m. to 1 p.m. The location is on the creek to the left of the picnic shelter in Greensprings Park. Sound Rivers is also seeking volunteers to help with the Greens Mill Run trash trap: volunteers who can regularly check to see if it's in need of a clean-out and those willing to wade into the water (gear provided) to pull trash from the traps. Those interested in volunteering can email Sound Rivers' Volunteer Coordinator Emily Fritz at emily@soundrivers.org.

The Greenville trash trap is sponsored by Grady-White Boats, Mid-Atlantic Fabrication and the Winston Family Foundation.



Subject: Convention Center Plaza Renovation Update

The Convention Center Plaza, located between the Convention Center Main Entrance and Greenville Boulevard, was constructed in 2008 in preparation for the Statewide NC League of Municipalities Conference in the fall of 2009. Over the last fifteen years, site conditions have declined impacting the visibility, walking surfaces, and overall aesthetics of the plaza.

The Public Works staff has a plan to renovate the plaza beginning in the late spring of 2024 and complete the project in the fall of 2024. The project will be completed with city staff and selected sub-contractors. Primary improvements will be:


- A complete landscape overhaul with new columnar trees, shrubs, and perennials



- New benches, trash receptacles, and sound system
- New catenary lighting and renovated aerial pole lights



- Expanded pedestrian/garden area with renovated pavers and hardscape
- Fountain removals and additional columnar tree plantings in those locations



- New cantilever shade shelters, if budget allows

The budget for the project is 300K and funded with Hotel Occupancy Tax funds. I have discussed this project with Greenville Convention Center and they are very excited for this project to move forward with the proposed plaza improvements.

Subject: GFR Implements Use of Life Safety Inspection Vault Application

Greenville Fire/Rescue will begin the onboarding process to implement the use of the Life Safety Inspection Vault (LIV), which is a web-based application provided to fire departments that collects, organizes, and stores fire and life safety system data pertaining to inspection, testing, and maintenance. LIV will allow GFR to view all reports submitted within our jurisdiction in one centralized location.

Implementation of LIV will allow fire inspectors to focus more time in the community conducting inspections. GFR will also benefit from being able to conveniently see data pertaining to deficiencies, impairments, past due inspections, and companies performing related work in our jurisdiction.

LIV will streamline the inspection reporting process and generate data for the fire department. The system will generate valuable metrics which will allow GFR to use a data-driven approach to prioritize fire prevention efforts, which will also aid in maintaining accreditation.

This program is available at no cost the City of Greenville.

Implementation of the Life Safety Inspection Vault application should be complete within 45-60 days with ongoing training available to all users. See the following link for additional information about the application: <https://www.youtube.com/watch?v=2h4e7A7tyDw&t=7s>.

Subject: Update on the 2050 Metropolitan Transportation Plan

On January 8, the Greenville City Council approved the contract to develop the 2050 Greenville Urban Area Metropolitan Transportation Plan. The Greenville Urban Area Metropolitan Planning Organization (GUAMPO) is required to update its long-range transportation plan titled the Metropolitan Transportation Plan (MTP) every five (5) years in compliance with Federal and State regulations. The MTP has a planning horizon of twenty-five (25) years and is created and maintained by the Metropolitan Planning Organization as part of its ongoing transportation planning processes. As per federal regulation 23 CFR 450, the update is done to align with the “3 C’s” of planning as defined in federal law: continuous, cooperative, and comprehensive. GUAMPO is working with Kimley-Horn to ensure that the development and adoption of the MTP main planning document is completed by the federal deadline of July 10, 2024.

GUAMPO has recently launched an online survey to update the MTP. The purpose of this survey is to gather public input and identify transportation needs. The MTP aims to identify improvements for all modes of transportation and create recommendations that efficiently and effectively move vehicles, pedestrians, bicyclists, and transit riders through the region. We encourage everyone to participate in the survey as it will help us address transportation deficiencies better. We aim to share this survey with the public through various communication channels and social media platforms.

The survey is available in both English and Spanish and can be accessed through the links provided below. Attachment 1 is the flyer we have prepared in English, and Attachment 2 is the Spanish version of the flyer. Please share this survey with any individuals or groups interested in providing feedback on the transportation systems within the Urban Area. The survey will be open through the end of March.
