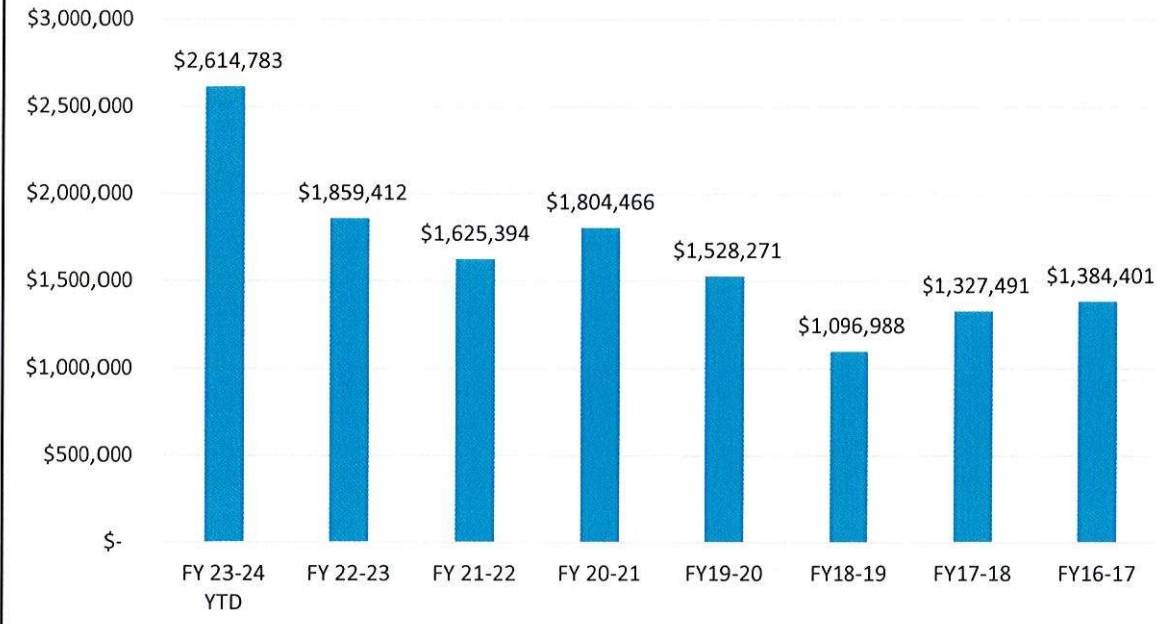

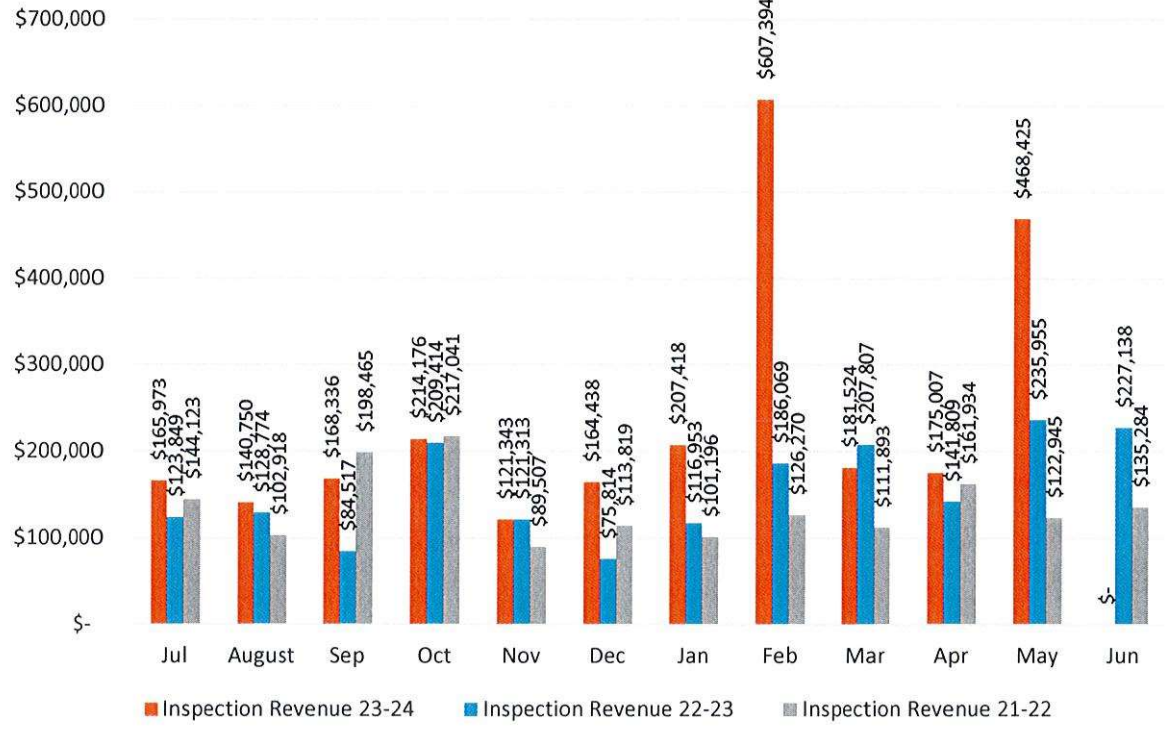

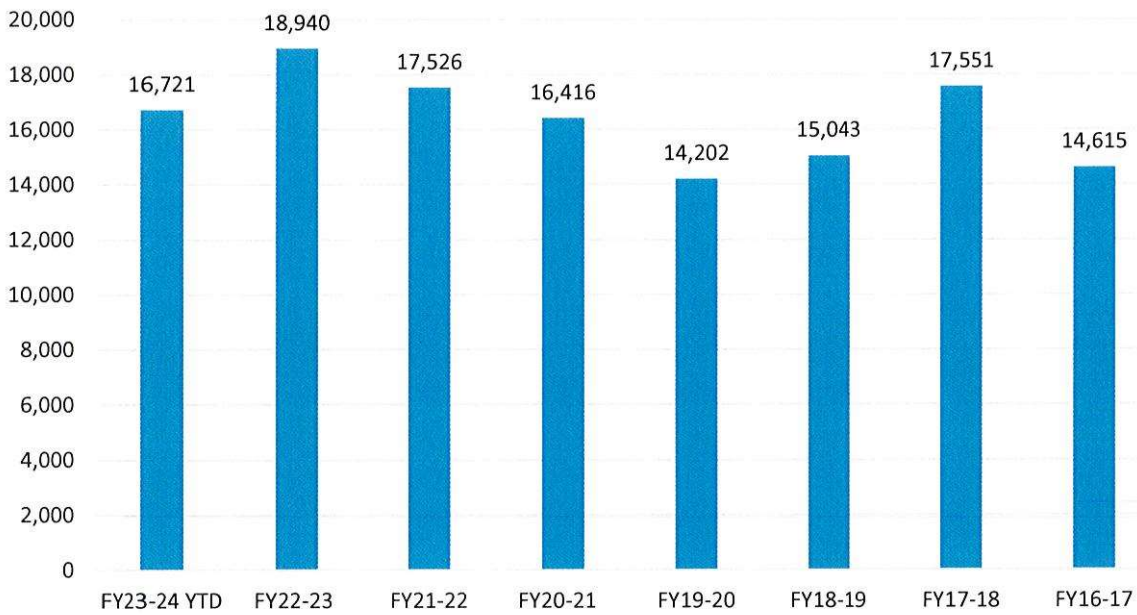
### Inspections Revenue by Fiscal Year
