Subject:	Fall 2024 Construction Training Program

In collaboration with the North Carolina Housing Finance Agency and the NC Homebuilders Association, the City of Greenville is offering an occupational training program tailored for low-to-moderate-income residents. Launched in August 2022, the program has successfully helped participants secure employment and expand their career prospects.

The program features hands-on instruction in construction theory, equipping participants with skills that enhance their employability with local businesses. Each year, the program runs two sessions—one in the spring and another in the fall—with each session accommodating 10 residents for an 8-week period. Participants receive training, books, tools, and a certificate upon completing the program.

The next session is scheduled for Fall 2024, with further details to be provided once the venue and dates are confirmed by the Neighborhood & Business Services Community Development Division.

Subject:	Mandatory Non-Profit Workshop

As part of the Annual Action Plan to the U.S. Department of Housing and Urban Development (HUD), the City allocates up to 15% of Community Development Block Grant (CDBG) funds each year for public services. These funds support the ongoing work of non-profit agencies that align with HUD's objectives. The CDBG Sub-Recipient Program aids local non-profits in their efforts to benefit low- and moderate-income individuals, reduce slum and blight, and address urgent needs within the Greenville city limits.

Eligible non-profits must meet specific local and federal requirements to participate in the program. Attendance at a workshop by a representative of the non-profit is a mandatory prerequisite for applying for funds. Agencies that attend one of the two sessions held on September 26, 2024, will meet this requirement.
