# ENVIRONMENTAL ADVISORY COMMISSION MINUTES DECEMBER 5, 2024

#### CALL TO ORDER

Members of the Environmental Advisory Commission met on the above date at 5:30 p.m. Municipal Building 2<sup>nd</sup> floor conference room, Dr. McKinnon, Chair, called the meeting to order and welcomed all those present. The following attended the meeting:

### 3. APPROVAL OF NOVEMBER 7, 2024, MINUTES

Dr. McKinnon stated that:

- misspelled and needs to be changed "to legislature" and "exception" under second paragraph in the announcements.
- needs to be added under seventh paragraph in the announcements "Daryl or Wanda would send out a reminder before the two-week deadline"

- wording change on fourth paragraph in the Old Business, "Related to not Development "changed to "it occurs prior to development", its needs to be a little clearer.
- Dr. McKinnon mentioned to end the sentence with "UDO. "And then add another sentence "UDO deals with development"
- "UDO deals with development" change to "It occurs prior to development"

We found out that they have past the eligibility review, that determines yes, that our project is eligible to be funded. Now it moves into the scoring and ranking. This grant is to build the Engineering building and second emergency operations center North of the River. Also, the Gymnasium/ Distribution Center at Greenville Terrace. Eight-to-Ten-acre Wetlands at Greenville Terrace and upfit the Boys and Girls Club with new LED lights, HVAC system, solar and EV Changing stations.
