Re:	Request for Monthly Sanitation Fee Increase

The Public Works Sanitation Division currently has a monthly service fee of \$16.00. This monthly fee is for the weekly collection of refuse, recycling, yard waste and scheduled bulk items. The monthly service fee has not been increased since fiscal year 2018.

Several factors are impacting the costs to provide these services to our residents. There have been significant increases in the cost of collection trucks, fuel, maintenance and operational supplies. Additionally, labor costs to provide this service have also increased. As a result, the monthly residential service fee will require an adjustment. This is necessary to keep our solid waste services operating as an enterprise fund.

Regional benchmark studies show our current sanitation fee is one of the lowest in the state. The proposed fee adjustment will keep the City's monthly sanitation fee within the benchmark ranges and accommodate increased costs associated with our operations. The average benchmark 2025 monthly rate for peer cities that offer similar service is approximately \$23. Note that almost all these cities do not offer a comparable level of service to Greenville.

As our population grows, the number of routes will also need to increase. We will need to add trucks and personnel. The contribution to our vehicle replacement fund will increase from \$1M to \$3M annually. Our personnel costs will increase by approximately 16% over the next three years to accommodate for the increased number of routes.

Staff used historical data to aid in the projection of the sanitation service fee for residents.

Two sanitation service fee options are presented below. The difference is that one option includes providing residential carts- one blue and one green – to our residents.

Proposed Roll Cart plan:	Residents pay a nominal monthly charge for their cart /dumpster, maintenance and replacement.
Current Roll Cart purchase:	Residents to purchase their cart(s). Currently \$90.00 per cart. This includes delivery and a 10-year warranty if purchased from the city.

The first alternative includes a cart/ dumpster rental fee: This fee option allows staff to address complaints in a timely manner so that we may provide consistent customer service: i.e. City trucks damaging private property (cart/ dumpsters). The second option is the fee for continuing to provide the weekly services currently performed by our Public Works personnel.
