Code Enforcement Update

Corporal Chris Viverette gave a Code Enforcement Update to the Commission. Code Enforcement is dedicated to addressing neighborhood concerns from both an advocacy and enforcement point of view. Staff members work on a variety of neighborhood concerns such as: minimum housing violations, abandoned structures, weeded lots, abandoned and junk vehicles and other public nuisances within the City. From a zoning perspective, we are also responsible for investigating portable signage violations and three or more unrelated violations. Our goal is to obtain Voluntary Compliance in order to abate the violation. Code Enforcement is involved with neighborhood improvement events and is in partnership with Rebuild Together. The City of Greenville's Spring Clean Up is under the guidance of Code Enforcement.

Ms. Diggs pointed out the tires located at the corner of Evans Street and Flretower Road.

Mr. Caspar: What is an unimproved surface?

Mr. Viverette: No vehicles are allowed to park on an unimproved surface.

The Commission thanked Mr. Viverette for the update.

Wildflower Project Update

Mr. Hines: The seeds for day lilies and roses have been ordered for the wildflower sites. There will be meetings held with volunteers about planting the seeds. The City will supply the tools.

Ms. Coles: When will we actually be on the grounds?

Mr. Hines: Recreation and Parks will meet with us for a concrete date. Residents of the neighborhood and the Neighborhood Advisory Committee will be met with as well.

Neighborhood Improvement Grant Update

Mr. Hines: The deadlines need to be changed to review the applications before bringing information and recommendations back to the entire Commission. A meeting needs to take place.
