It was also suggested the group contact Cori Hines on the Neighborhood Advisory Board to present information to neighborhood associations currently working on projects to be considered for the award.

**D. EECBG Update**

Wes Anderson reported that approval had been received on all areas of the grant. City Council approved the budget amendment for monies to be spent. The three areas of the grant that have gone well are the Revolving Loan Grant, LED Street Lighting Pilot Project along Arlington Boulevard from Evans Street to Memorial Drive, and the Rebate Program for LED street lights in housing developments. Two (2) submittals have been received for the E300 Extended Rebate Program (Bill Clark and Teakwood Green). Two remaining areas that are in the works are MG Star and Existing Multifamily and Commercial Building for energy audits. Request for Proposals are being completed and will be sent out for the Guaranteed Energy Savings Performance Contract.
