  - South Tar River Greenway Board of Transportation is meeting today and tomorrow, will consider additional funding requested to fully fund the project. Consultant has indicated will be dealing with 30+ properties for easements which

requires revising the schedule. Advertising for construction bids will now be October 2014.

- 3. Dickinson Ave In early stages of scope development with NCDOT. Cross sections not set yet, will balance needs of motorized vehicles, bikes, pedestrians, and parking for businesses. There will be public meeting opportunities for the project, just as have been for Evans St/Old Tar Road widening project. More to come as design moves forward.
- B. Recreation and Parks
  - 1. Greensprings Park GUC is realigning old sewer lines.
