## Greenville Bicycle and Pedestrian Commission Work Plan for 2014

- I. Working with other Commissioners and City Staff to:
  - a. Prepare an Ordinance related to sidewalks at commercial establishments
  - b. Review the 2014 Planned City Street Improvements/Upgrades
  - c. Publicize, Generate Interest and Support for the Charles Blvd to Evans St project and the Phase III Greenway extensions (Education/Encouragement Sub-Committee)
- II. Nation Bicycle Month (May) Katy Kavanagh
  - a. 5/18 City Council Bike Ride on the Greenway
  - b. Check with Pamlico/Tar River Foundation for involvement in River Jam in April. Event is in April and was not well attended last year.
  - c. Check with Jennifer Smith about helping organize a Bike to School Day or any other events.
  - d. 5/13-17 Bike to Work Week publicize this and attempt to organize something
  - e. After Bike Month, think of furthering publicity, including a FROGGS like PSA Video, perhaps enlisting Thomas Lynch with No Exit video to donate the video production; much of the same footage could likely be used.
- III. Spearhead the National Bicyclist and Pedestrian National Census Continue annual bike/ped counts in conjunction with the National Bicycle and Pedestrian Documentation Project (<u>http://bikepeddocumentation.org/</u>). National count dates are:
  - a. May 6-8, 2014
  - b. July 4-6, 2014
  - c. September 9-14, 2014
- IV. Work toward Walk-Friendly Community Designation (Pedestrian and Bicycle Information Center, <u>http://www.walkfriendly.org/</u>)
- V. Identify and quantify dangerous street crossings in the city (see also Enforcement Subcommittee)
- VI. Collect public input regarding:
  - a. Revisiting rules for maximum wheel size for bicycles operated on sidewalks
  - b. Engage with BMX community (perhaps even encourage a member to join the Commission)
